Church Street for a 12 year old juvenile assaulting a staff member, when I arrived I spoke to the victim Madison Hardin and she told me that she tried to get the juvenile to leave the day room and when he got to the door where she was at he hit her with a closed fist in the chest area leaving a red mark.
