NARRATIVE

I RESPONDED TO 6501 WEST 12TH STREET FOR A RESCUE JUMPER CALL. COMMUNICATIONS ADVISED A JUVENILE WAS ON THE ROOF OF THE BUILDING AND REFUSING TO COME DOWN. UPON ARRIVAL, I WAS INFORMED BY STAFF THE JUVENILE HAD COME DOWN FROM THE ROOF. I MADE CONTACT WITH THE JUVENILE, JUVENILE 1, WHO WAS ATTEMPTING TO FIGHT OTHER JUVENILES AND STAFF. I PLACED JUVENILE 1 IN HANDCUFFS AND SECURED HER IN A PATROL VEHICLE. JUVENILE 1 ADVISED SHE WAS FIGHTING WITH ANOTHER JUVENILE IN THE COURTYARD, AND ADVISED SHE CLIMBED ONTO THE ROOF TO RETRIEVE HER SHOE THAT WAS THERE, AND ALSO TO ESCAPE THE FACILITY. JUVENILE 1 ADVISED SHE WAS NOT HAVING SUICIDAL OR HOMICIDAL THOUGHTS.

I MADE CONTACT WITH JUVENILE 2, WHO ADVISED SHE WAS ASSAULTED BY A STAFF MEMBER, [REDACTED] JUVENILE 2 ADVISED SOMEONE SET OFF A FIRE EXTINGUISHER IN ONE OF THE DORMS, SO THE DORM HAD TO BE EVACUATED TO THE COURTYARD. JUVENILE 2 ADVISED EVERYONE IN THE COURTYARD STARTED FIGHTING, SO SHE BEGAN FIGHTING [REDACTED] JUVENILE 2 ADVISED [REDACTED] PUNCHED HER IN THE FACE. JUVENILE 2 ADMITTED TO STRIKING [REDACTED] FIRST.

I MADE CONTACT WITH [REDACTED] WHO ADVISED HE WAS TRYING TO GET JUVENILE 1 DOWN FROM THE ROOF, WHEN JUVENILE 2 SWUNG AND CONNECTED WITH A PUNCH TO HIS FACE. [REDACTED] ADVISED HE PUT UP HIS HANDS AND TRIED TO PUSH JUVENILE 2 AWAY, BUT SHE KEPT ADVANCING ON HIM. [REDACTED] ADVISED HE THEN REMOVED HIMSELF FROM THE AREA. [REDACTED] WAS NOT INTERESTED IN PURSUING CHARGES OF ASSAULT.

MEMS RESPONDED AND CHECKED BOTH JUVENILES 1 AND 2. JUVENILE 2 WAS TAKEN BACK INSIDE THE FACILITY. OFFICERS TRANSPORTED JUVENILE 1 TO CHILDRENS HOSPITAL WITHOUT INCIDENT.
