On 08/22/2022 at approximately 2:00 pm Officers responded to 600 N. 7th in reference to a runaway juvenile. Upon arrival Officers made contact with Perimeter staff who advised that [REDACTED] (suspect) was being loaded onto a transport van when he fled from staff. While sitting in the waiting room [REDACTED] returned to the scene crying and apologizing for running away from staff. Perimeter nurses did not want to pursue charges and requested if Officers could trail them to Crittenden County Juvenile Detention Center in which we complied. [REDACTED] was transported to Crittenden County Detention Center without further incident.
