On this date I was dispatched to Dacus on Church Street for two runaway male juveniles, when I arrived Charles the worker there said that the two juvenile white males had gotten the keys from another worker and left the facility unknown direction of travel, I contacted Chief Parrish and let him know that Officer Loggins and I was looking for the juveniles then he and Officer Fraser came out and deployed the drone we were advised by dispatch that the juveniles were seen in a back yard on North Deborah Street all units went to the location and that's all I have at this time. the juveniles have been enter into ACIC.

**Narrative - Fraser, Jason - 8/27/2022 1:26:02 PM (Initial)**

On 8/27/2022 I Officer Fraser was called out for a drone deployment. I was advised 2 male juveniles had left in a unknown direction. I flew the fields and wood line near the facility. I was unable to locate the suspects after utilizing 3 batteries. I continued to search by ground in my patrol unit for a couple more hours.

On 8/27/22 at 1815 hours I was contacted by Daniel Haynes and he said that his juvenile son and his friend was located in Baxter County and that they were bringing them back to the Dacus Facility in Bono. I contacted dispatch to get this confirmed and remove them the system.. Dispatch has advised me that its confirmed and that Gary Hefler was transporting them back.
