On this date I was dispatched to 211 church Street for a large fight between staff and clients, when I arrived Officer Jason Fraser was already there and trying to get in after several minutes staff came and let us in to the facility and took us to a room with two juvenile white males were and two staff members, Jermain Archield the facility Manager said that these two juveniles was destroying property and fighting staff no one was injured nor did they have marks from being hit Deputy Logan Dotson arrived and stayed with me to watch the juveniles and Officer Fraser went around and looked at the damages and contacted Juvenile Officer Amy Powell, after a few minutes Officer Fraser advised me to go ahead and arrest the juveniles purr Officer Powell. Juveniles were arrested for Criminal Mischief and Officer Fraser and I transported to the Detention Center where they were booked in on the above charge.

On 8/27/2022 I assisted Officer McGinnis at Complainant (Dacus Residential Treatment Center). On my arrival i attempted to make entry all doors were locked. A kitchen worker came around and let us in. As we were making entry we could hear them beating on the windows. As we entered the room they were semi combative. They did refuse to listen to our orders. I let Officer McGinnis handle them as i walked through the building looking at the damage. I observed a door that was kicked in the kitchen. A door with damage to the magnet that is keeping it from locking and a door with a damaged latch. In the bathroom the tore up the soap dispensers and had soap on walls and floors. I obtained information for a report. I contacted Amy Powell of the Craighead Juvenile Dept who authorized them to be arrested and transported to the Jail.
