Case Narrative

On August 30, 2022, at 1437 hours, I, Officer Trey Fales #479, responded to Piney Ridge, 4253 North Crossover Road, in reference to a missing person complaint.

Upon my arrival, I made contact with Cole Mitchell, who is an employee of Piney Ridge. According to Cole, [REDACTED] ran away from Piney Ridge. [REDACTED] was last seen wearing a white t-shirt, gray pants, and possibly a gray ball cap. [REDACTED] jumped over the fence in the playground area on the northwest side of the building. [REDACTED] then ran south down the fence line towards the wooded area and this was the last time Cole saw [REDACTED].

[REDACTED] is from Carle Stream, Illinois and he is a resident at Piney Ridge due to him conducting sexual acts with his younger sister and younger brother. Cole stated he did not believe [REDACTED] knew anybody from the Fayetteville or Springdale area. [REDACTED] also did not have any type of health issues that could put [REDACTED] in danger. I advised Cole if she received any information about [REDACTED] to contact the Fayetteville Police Department.

Officer Justin George #375 and I searched the wooded area where [REDACTED] was last seen. We walked from the south side of Piney ridge to the wooded area to the southwest. We followed the wooded area west to Old Missouri Road but were unable to locate [REDACTED].

I called [REDACTED] mother, [REDACTED] confirmed [REDACTED] did not know anybody from Arkansas. I advised [REDACTED] if she received any information about [REDACTED] to contact the Fayetteville Police Department.

[REDACTED] was entered as a missing person into NCIC/ACIC. I advised central dispatch to upload a BOLO on the briefing log with a picture.

At 1837 hours, [REDACTED] called me. [REDACTED] said [REDACTED] called her from TownePlace Suites in Johnson. I notified Johnson Police Department.

This was the end of my contact. I was patrol unit 1328 and my MVR and body-worn camera were both on. See Officer George's narrative supplement for further.

Case Summary

On 8/30/2022, at approximately 7:30 PM, I was dispatched to 4253 North Crossover Road (Piney Ridge) for a follow-up report on a recovered juvenile.

I made contact with an employee, Reed Edward, at Piney Ridge. Reed brought the Juvenile, [REDACTED] to me. I confirmed [REDACTED] identity and that he was back in the custody of Piney Ridge staff. [REDACTED] told me he ran away because he wanted space and he didn't want to stay here (Piney Ridge) anymore.

I made contact with Officer Shelby West #12 of the Johnson Police Department via phone. Officer West said he recovered [REDACTED] at the Marriott hotel within his city. Officer West provided an address of 5437 South 48<sup>th</sup> Street for that hotel. Officer West informed me [REDACTED] had contacted his mother who in turn contacted the police department. Officer West said he transported [REDACTED] to Piney Ridge per the request of Officer Fales #449.

I requested dispatch to have [REDACTED] removed as a missing person.

During this incident, my BWC and MVR were active. I was in unit 1293.
