NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION FOR A RUNAWAY REPORT. UPON ARRIVAL, OFFICERS MADE CONTACT WITH JACKSON. JACKSON STATED J1 WAS LAST SEEN WEARING A WHITE SWEATER AND WHITE JOGGERS AROUND 1905 HOURS. JACKSON ADVISED J1 LEFT THE PROPERTY HEADING NORTHBOUND ON FILLMORE STREET. JACKSON STATED J1 RAN AWAY LAST NIGHT, BUT RETURNED THIS MORNING.

OFFICERS CIRCULATED THE AREA WITH NEGATIVE RESULTS. A RUNAWAY BROADCAST WAS MADE. OFFICERS PROVIDED JACKSON WITH AN INCIDENT NUMBER. OFFICERS EMAILED ACIC WITH J1'S INFORMATION.

ON 09/06/2022 AT APPROXIMATELY 0045 HOURS, OFFICERS WERE DISPATCHED TO 8115 FRENCHMAN'S LANE FOR SUSPICIOUS ACTIVITY(2022-106107). UPON ARRIVAL, CONTACT WAS MADE WITH THE LISTED JUVENILE. WE RAN A RECORDS CHECK, AND FOUND OUT HE WAS LISTED AS A RUNAWAY. DUE TO THIS FACT, HE WAS RETURNED TO THE METHODIST CHILDREN'S HOME AT APPROXIMATELY 0119 HOURS. BEFORE OFFICER'S WERE ABLE TO TAKE HIM OUT OF THE SYSTEM, THE METHODIST CHILDREN'S HOME CALLED AT APPROXIMATELY 0203 HOURS, TO NOTIFY US HE LEFT THEIR PREMISES AGAIN. THE SUBJECT IS STILL A RUNAWAY. 3X50(MOORE) RESPONDED TO THE LOCATION AND CONFIRMED THE SUBJECT LEFT. NO FURTHER INFORMATION WAS AVAILABLE AT THIS TIME, AND OUR BWC'S WERE ACTIVE WHILE ON THIS CALL.
