NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION TO THE LISTED LOCATION FOR A BATTERY IN PROGRESS. UPON ARRIVAL OFFICERS MADE CONTACT WITH ADAMS, BEHAVIOR INSTRUCTOR FOR METHODIST HOME FOR CHILDREN. ADAMS ADVISED JUVENILE 1 AND 2 WHERE IN A PHYSICAL ALTERCATION. ADAMS STATED JUVENILE 2 WAS THROWING BOOKS AND FLIPPING TABLE. ADAMS STATED JUVENILE 2 THREATENED TO KILL HER.

JUVENILE 1 STATED HE WAS POKING JUVENILE 2 IN A PLAYFUL MANNER, HOWEVER, JUVENILE 2 WAS ALREADY ANGRY. JUVENILE 1 STATED HE PUSHED JUVENILE 2 AND THEN THEY GOT INTO A FIGHT. JUVENILE 1 STATED HE PUNCHED JUVENILE 2 MULTIPLE TIMES AND GAVE HIM A BLOODY NOSE.

JUVENILE 2 STATED HE WAS ALREADY ANGRY WHEN JUVENILE 1 BEGAN TAPPING HIM. JUVENILE 2 STATED HE STOOD UP AND BEGAN PUNCHING JUVENILE 1 IN THE STOMACH MULTIPLE TIMES. JUVENILE 2 STATED HE NEVER THREATENED TO KILL ADAMS.

WHILE OFFICERS WERE LEAVING JUVENILE 1 BEGAN THROWING ROCK AT THE BUILDING AND WINDOW, HOWEVER, NONE WERE BROKEN.

OFFICERS WERE DISPATCHED TO THIS LOCATION FOR A CRIMINAL MISCHIEF CALL. ADAMS ADVISED JUVENILE 1 WAS BREAKING OUT WINDOWS WITH HANDS AND ROCKS. UPON ARRIVAL OFFICERS WERE ADVISED THE METHODIST HOME HAD CALLED FOR MEMS TO TRANSPORT TO CHILDREN'S HOSPITAL, DUE TO JUVENILE 1'S BEHAVIOR. OFFICERS WERE ALSO INFORMED THAT JUVENILE 1 WOULD BE HOSTILE.

OFFICERS ESCORTED ONTO THE GURNEY AND HANDCUFFED HIM TO THE RAILS. IT SHOULD BE NOTED JUVENILE ONE ATTEMPTED TO HEAD BUTT OFFICERS HANDS, BITE OFFICERS, AND ATTEMPT TO GET HIS HANDS OUT OF THE HANDCUFFS. OFFICERS HAD TO HOLD HIS HEAD IN ORDER TO AVOID BEING BITTEN. OFFICERS OBSERVED BLOOD ON JUVENILE 1'S RIGHT HAND, FROM AN INJURY SUSTAINED WHILE BREAKING THE WINDOWS WITH HIS HANDS.
