NARRATIVE

OFFICERS RESPONDED TO 6425 WEST 12TH STREET FOR DISTURBANCE.

OFFICERS WERE ADVISED THE SITUATION STARTED WHEN A FIGHT BETWEEN VICTIM 1 AND SUSPECT 2 OCCURRED OUTSIDE. SUSPECT 3 TOOK ADVANTAGE OF THE SITUATION, AND BEGAN TO HIT VICTIM 1, ALSO. THIS CREATED A "CODE RED" WHERE MOST OF THE EMPLOYEES HAD TO GO TO THIS LOCATION. AFTER THIS A FIGHT STARTED INSIDE. THEY HAD TO RESPOND BACK INSIDE, WHERE A FEW CHILDREN STARTED BREAKING THINGS. MS. KENLIGH BENNETT STATED SHE SAW SUSPECT 5 ATTEMPTING TO LEAVE OUT OF A BACK DOOR. HE BEGAN KICKING THE DOOR UNTIL IT HAD BROKEN. THIS ALLOWED SEVERAL CHILDREN TO GET OUT OF THE DOOR, BUT ALL OF THE CHILDREN WERE ABLE TO BE LOCATED AND RETURNED TO THE LOCATION.

AFTER THIS VICTIM 1 STATED SUSPECTS 2, 3, AND 4 BEGAN ASSAULTING HIM. HE STATED HE DID NOT KNOW EXACTLY WHAT HAPPENED BECAUSE IT HAPPENED SO FAST, BUT HE WAS STRUCK WITH CLOSED FISTS ON HIS BODY. HE OBTAINED A CONTUSION TO HIS RIGHT FOREARM FROM THE ALTERCATION.

OFFICERS ARRIVED ON SCENE AND SAW EMPLOYEES ATTEMPTING TO CORAL CHILDREN BACK INTO THE BUSINESS, BUT WAS INFORMED THAT SEVERAL CHILDREN INSIDE CAUSING A LARGE DISTURBANCE. OFFICERS WERE ABLE TO GAIN ENTRY INSIDE TO SEE A LARGE GROUP OF KIDS YELLING, AND SOME BREAKING THINGS. OFFICERS WERE ABLE TO GET MOST OF THE CHILDREN TO STOP THE DISTURBANCE AND GO INTO THE AREAS DESIGNATED BY EMPLOYEES. BUT SUSPECT 1 STANDING ON TOP OF A COUNTER KICKING GLASS. OFFICERS WAS ABLE TO CONVINCE THE SUSPECT 1 TO GET OFF THE COUNTER. OFFICERS ALSO SAW SUSPECT 2 BREAK PARTS OF THE WOODEN AREAS OF THE COUNTER AND TABLES IN THE AREA. AS THINGS SETTLED OFFICERS WERE ABLE TO GET INFORMATION OF THE INCIDENT.

DURING THE ALTERCATION WHILE OFFICERS WERE ATTEMPTING TO CALM THE SITUATION. OFFICERS WERE ATTEMPTING TO DETAIN SUSPECT 1. HE BECAME COMBATIVE, AND ONE OF THE OFFICERS DEPLOYED SOME PEPPER SPRAY TO ASSIST IN DETAINING THE SUSPECT. OFFICERS WERE ABLE TO DETAIN SUSPECT 1 AFTER THIS. MEMS WAS CALLED TO THE SCENE TO ASSESS INJURIES FOR ALL INVOLVED PARTIES. VICTIM 1 WAS TAKEN TO CHILDREN'S HOSPITAL BY MEMS FOR INJURIES, BUT DETERMINED NO BROKEN BONES OR SERIOUS INJURY. SUSPECT 1 WAS ASSESSED FOR THE PEPPER SPRAY AND WAS NOT INJURED. AND MEMS PERSONNEL TALKED TO SEVERAL OTHER INDIVIDUALS ON SCENE AND DETERMINED THERE WERE NO FURTHER INJURIES FROM PARTIES INVOLVED.

OFFICERS CONTACTED DETECTIVE TIM EVANS. IT WAS DETERMINED THAT THE BUSINESS SHOULD ATTEMPT TO GET AN ITEMIZED LIST OF DAMAGES. MS. KENLIGH BENNETT WAS INFORMED OF THE THIS. SGT THOMAS RESPONDED TO THE SCENE.
