On 07.12.22, Risk received a report [REDACTED] about client [REDACTED] reported that Behavioral Health Associated [REDACTED] had hit [REDACTED] in the head. Facility visited 7/18/22 from 10:30AM-12:00PM, Risk Mgmt. Jlynn Perkins present. [REDACTED] interviewed. [REDACTED] asked to demonstrate what happened. [REDACTED] stated that other kids were "coming after me and I fell in another kid's room" and that staff member "hit me on the head". [REDACTED] asked to demonstrate what was happening prior to being hit. [REDACTED] gave one scenario where [REDACTED] was lying on the ground. [REDACTED] was asked if [REDACTED] felt, saw or both felt and saw staff hit [REDACTED] "I saw a little bit". [REDACTED] was asked to demonstrate again what [REDACTED] saw staff do at which point [REDACTED] demonstrated a scenario where [REDACTED] was standing and was hit in the head. No definitive evidence to support violation of minimum licensing standards at this time.

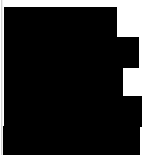
