## Notice of Incident

**Incident Description:** This incident occurred at Youth Home (Mabee House PRTF) 7/29/22. At 8:58AM client [REDACTED] was upset [REDACTED] could not be relieved of Run Risk, Supportive Status and House Restriction. [REDACTED] went in [REDACTED] room and pulled a mirror (reflective metal mirror) off the wall. [REDACTED] attempted to obtain screws from mirror to self-harm. Staff intervened and initiated a restraint. Staff processed with client, and [REDACTED] was able to calm down. Eyeball was added to other supportive measures. Around 2:10PM 7/29/22 [REDACTED] became upset [REDACTED] could not have markers instead of crayons while on Eyeball. [REDACTED] ran to a bathroom and barricaded the door. Staff had to force the door open and initiate a restraint. [REDACTED] later was able to process with staff and calm down. [REDACTED] was transported via MEMS to [REDACTED].

**Agency's Interim Corrective Action:** Client was restrained for her safety. Client transported to [REDACTED] via MEMS.

**Details from Follow-up:** Email from Youth Home 8/2/22 states: According to our discharge planner, Methodist informed [REDACTED] yesterday that it is estimated [REDACTED] will discharge from [REDACTED] on [REDACTED]

Thursday 8/4/22. Facility visited 8/3/22 and video from 7/29/22 reviewed from 8:58AM-9:40AM Banging heard in audible on video. One staff goes in [REDACTED] room, exits to use the house phone to make an All-Call, then re-enters room. Additional staff show up around 9:01AM. All staff are seen entering bedroom. Staff and [REDACTED] exit room around 9:40AM. Video reviewed from 2:05PM-2:25PM. Staff seen and heard in Mabee hallway counseling client regarding markers vs. crayons whilst on Eyeball. Client quickly ducks into the bathroom beside [REDACTED] and barricades door shut. Staff seen all pushing door open. Staff and client off camera in bathroom, client processing with staff. Client seen exiting bathroom, followed by staff. [REDACTED] then runs down the hall and into the kitchen. [REDACTED] heard yelling. Staff follow [REDACTED] into the kitchen off camera. [REDACTED] calmed down around 2:30PM without further incident.

No visible nor audible licensing concerns observed in video regarding this incident.
