Staff seen restraining [REDACTED] until 2:29PM. No inappropriate holds nor licensing concerns observed regarding this incident. This incident self reported by Youth Home 8/2/22. Youth Home made this hotline call 8/2/22 for alleged maltreatment.

Facility visited 8/3/22 from 9:00AM-1:00PM. 2 staff seen present at front station, [REDACTED]. At 1:38PM [REDACTED] is asked to go to [REDACTED] room twice which [REDACTED] refuses. A 5 count is given to [REDACTED] both times. After the second request [REDACTED] is seen escorting client into [REDACTED] room. Nothing can be seen after this point. Client at one point is heard yelling "you aren't going to grab me like that". Most other audible from client is obscenities. Nurse [REDACTED] is seen in the doorway of [REDACTED] s room and [REDACTED] is heard talking calmly.

[REDACTED] consulted today regarding incident. [REDACTED] did have a scratch on [REDACTED] orso area after restraint. The scratch reported to be reasonable considering a recent hold/restraint. Additionally, [REDACTED] reports client [REDACTED] s proclivity to defend [REDACTED] self while in a restraint may cause referenced scratch.

No licensing concerns, inappropriate holds nor abusive language from staff, observed or heard in video. Nurse present today's visit reports scratch sustained from hold was reasonable for a hold.

Email from Youth Home 8/2/22 states: According to our discharge planner, Methodist informed her yesterday that it is estimated [REDACTED] will discharge [REDACTED] on Thursday 8/4/22. Facility visited 8/3/22 from 9:00AM-1:00PM. Banging heard in audible on video. One staff goes in [REDACTED]'s room, exits to use the house phone to make an All-Call, then re-enters room. Additional staff show up around 9:01AM. All staff are seen entering bedroom. Staff and [REDACTED] exit room around 9:40AM. Staff seen and heard in Mabee hallway counseling client regarding markers vs. crayons whilst on Eyeball. Client quickly ducks into the bathroom beside [REDACTED] and barricades door shut. Staff seen all pushing door open. Staff and client off camera in bathroom, client processing with staff. Client seen exiting bathroom, followed by staff. [REDACTED] then runs down the hall and into the kitchen. [REDACTED] heard yelling. Staff follow [REDACTED] into the kitchen off camera. [REDACTED] calmed down around 2:30PM without further incident.

Facility visited 8/3/22 from 9:00AM-1:00PM. Two clients (one whom is [redacted] seen throwing chairs and pushing TV on the ground, heard saying "riot". Staff are heard calling All Call while clients continue to pace the milieu. [redacted] is seen going off camera to [redacted] room. Staff follow (for reported hold/restraint due to attempting self-harm). Later [redacted] seen escorted out of room and out of Sturgis without further incident. Staff report while off camera, [redacted] had wrapped a shirt around [redacted] neck. [redacted] was placed on Eyeball after this incident. Other client seen and heard alerting staff there was

something wrong in a room. Staff enter room and then All Call was made. Additional staff enter Sturgis to restrain client. [redacted] eventually calmed down and restraint was lifted. Staff and client seen leaving room into milieu. [redacted] transported [redacted] this afternoon.
