## Narrative

On 9/26/2022, at approximately 0854 hrs I was dispatched to 161 Skunk Hollow Rd. for a theft of property report.

I arrived on scene and made contact with Mr. Matthew Wiltshire (complainant) who took me back to the security camera room of Little Creek Behavioral Health to show me the camera footage of their smoker trailer being stolen from the back parking lot of the building. What appeared to be a late 90's to early 2000's model white chevy truck extended cab with black trim down the bottom's of the doors pulls on to the property where the grill is located at approximately 7:58 p.m. The driver of the truck exits the vehicle to remove the ball lock off the trailer before backing the truck up to the trailer. By 8:02 p.m. the truck was leaving the property with the smoker trailer (listed in the property section of this report). It was a trailer mounted smoker with a side grill, sink, two propane lines, firebox on back, and stamped CMP (Custom Metal Projects) on the back. The VIN number is listed in the property section of this report.

I sent an ACIC property entry form to dispatch and a BOLO was issued for the smoker trailer. Mr. Wiltshire is working on getting the camera footage downloaded and will contact the Sheriff's Office when he has it ready. Due to the picture quality I was unable to get a license plate number or a description of the driver, All photographs were uploaded to "Patrol Pics" attached to this report number.

I provided Mr. Wiltshire with his report number and advised him to contact the Sheriff's Office if he needs any further assistance.


