**NARRATIVE**

OFFICERS MADE CONTACT WITH MS. JENNIFER HENRY (PR) WHO STATED THE JUVENILE CONTACT WAS REFUSING TO GO TO SLEEP AND LOCKED HIMSELF IN THE MAIN OFFICE. MS. HENRY STATED TO OFFICERS THAT IT WOULD BE FINE FOR THE JUVENILE CONTACT TO GO TO BED FOR THE NIGHT AND IT WILL BE FINE. THE JUVENILE CONTACT CALMLY WALKED TO HIS BEDROOM WITHOUT INCIDENT. OFFICERS ADVISED MS. HENRY TO CALL BACK IF ANOTHER INCIDENT OCCURS. BWC IN USE.
