Incident Description: It was reported that resident [REDACTED] was placed in physical containment on 8/13/2022 after throwing water in a staff member's face. The physical containment was considered unjustifiable per facility. Per incident report, staff member was observed on camera footage blocking the entrance and pushing the resident, posturing at resident with closed fist, picking up the resident and throwing the resident into a chair in the day room. [REDACTED] attempted to run away when staff grabbed [REDACTED] arms.

Agency's Interim Corrective Action: Resident was assessed by nursing staff while in constraint. [REDACTED] suffered a broken fingernail. Staff member terminated on 8/16/2022. Hotline called on 8/16/2022.
