at 8:00pm ER Visit At 710pm had three episodes of vomiting within a couple minutes. Held off from giving medications until a little later. Told him to use a cool towel and place on his neck or forehead. As well as to lay down. At 758pm I administered his medication and had him sit in the seat in front of the nursing station. At 800pm Pt fell out of the chair and landed on his side. Did not notice him hitting his head. He started to have convulsions. I went and support him by holding him on his side. He seizure lasting only a few seconds. I then called Lacey RN. At 801pm He started to have his second seizure within a few seconds of having his first. He did hit his head on the floor. I then supported his head and Said, "I need a pillow." That is when Ruthie Horton came to and helped and said there is one in the nursing office. When she got there to help support him I went and got the pillow and put under his head. After his second seizure he was able to communicate with no slurring speech. He wanted to get up. I told him to stay there for a bit and relax. At 803pm I called 911. While on the phone with 911 Pt had his 3rd seizure. Ruthie Horton was by him during this time. He was in eye sight of me the whole time. This only lasted about 20 seconds. At 804pm He went into another seizure with convulsions with Ruthie Horton behind him. pillow under his head. This lasted only for about 15 seconds. He came to looking around and was speaking to us. At 819 Liz Rn came into the house and started to do a neuro assessment. At 821pm Fire department showed up to the house and was giving report to them. At 823pm Had his 5th seizure while fire department was there and helping keeping him on his side and safe. Lasting only 22 seconds. At 824pm had his 6th seizure while fire department was there and help keeping him on his side and safe. lasting only 6 seconds. At 826pm Had his final seizure while on the unit. With the fire department was here. At 828pm had his 6th seizure while fire department was there and help keeping him on his side and

safe. He was then placed on a stretcher and taken to ACH ED for further assessment with ambulance as transportation. At 936pm his father did call back after two attempts. 08/22/22 at 8:19pm Nursing Face to Face assessment completed by Elizabeth Larson, RN Received pt laying on the floor in hallway/common area. Pillow under head. Pt AAOX3. PERRLA, Neuro Check complete. Short term and long term memory intact. No injuries apparent. Pt continues to have some seizure activity . Parent Notification at 9:36pm returned the call to the nursing cell phone and was notified at 9:36pm.
