While walking to his seat he then passed it alone to another resident. Actions Taken: The resident was searched by staff, the vape pen was found in the classroom. The resident have been placed on line of sight and will continue to be closely monitored by staff and nursing while in the classroom and milieu. The staff member has been suspended pending further investigation.
