Report Description: AV is She is currently in DHS custody in Sebastian County. AO is, an employee at Centers for Youth and Families in Little Rock, AR (age unknown). While at the Centers for Youth and Families had a conflict with a peer. During the conflict, grabbed hair and drug her by the hair into the hallway. There were no injuries indicated, but getting her hair touched is a trigger to strauma. On another occasion, needed to use the restroom. It is unsure whether he would not let her go to the restroom or if it were just unavailable at the time. However, ended up having an accident and sitting in soiled clothing for an hour or two because refused to give her new clothing. It was believed that her clothes were not washed so she was going to re-wear dirty clothes, but he would not let her. Its unsure how the situation was resolved. These are the incidents described that contribute to feeling unsafe there. These incidents are believed to be relatively recent described as of the reasons that she keeps acting up. It is unknown if this has happened to anyone else. No other information was provided.
Interim Action Narrative: placed on administrative leave pending investigation.
