Report Description: [REDACTED] [REDACTED] County) had a string of behavioral issues on 9/16/22 in the evening with [REDACTED] (DOB [REDACTED]). BHA [REDACTED] and other staff members had to intervene more than once between [REDACTED] and the other resident. Reportedly, [REDACTED] had hit the BHA [REDACTED]. While staff including [REDACTED] was intervening by placing [REDACTED] in a physical hold, allegedly [REDACTED] was yelling and spitting on the staff. [REDACTED] forced his way out of the restraint and reportedly was swinging over one of the staff's head to hit [REDACTED]. Staff member [REDACTED] reported that [REDACTED] was behind the other staff and was swinging at [REDACTED] and hit [REDACTED] on the head. Another staff member [REDACTED] reported the same report. It appears that LPN [REDACTED] was involved in the restraint along with [REDACTED], another staff member. At this time [REDACTED] was directed off the unit. [REDACTED] was assessed after the situation and it appears his only injuries was from the altercation with the other resident. It is noted that the LPN, [REDACTED] who was present at the restraint, stated that [REDACTED] placed his hands in front of him to fend off blows from [REDACTED] trying to hit him and that from her perception, [REDACTED] was not attempting to hit [REDACTED] [REDACTED] [REDACTED] [REDACTED]

Licensing Specialist received a complaint on 9/20/2022 that a resident [REDACTED] was placed in a physical restraint and allegedly hit by a staff member [REDACTED]. Licensing Specialist sat in on the interview with resident and Investigator Chiddister. Resident reported that he was placed in a hold against the wall by [REDACTED] and that [REDACTED] was informed that he was not needed. Resident also reported that [REDACTED] tried to push [REDACTED] out of the way when he was hit in the face and stomach by [REDACTED] with closed fist. Licensing Specialist observed what looked like circular scars on the left side of resident's face. He reported the scars were from a bite mark from the resident [REDACTED] that he got into it with.

Licensing Specialist and Investigator Chiddister viewed camera footage. What the resident reported was different from what was viewed. [REDACTED] (staff member) is the staff that put the resident in the physical restraint and not [REDACTED]. Due to the angle of the camera, Licensing Specialist was not able to view the entire incident.

Licensing is not prepared to leave a finding at this time.
