Incident date/time: 09/23/22 12:30pm Incident Description: Threat to Safety Staff Involved: Tyteonia Morgan, Jacqueline Wheeler, Rodney Ellis, J'Breun Sprinkle, Gregory Nesdahl-nurse, Robert Page, Taylor Tull Events Leading: Client was angry about having to remain at school. Client continually said "I am not staying in here". Staff offered to help provide coping skills or to play music of her choosing. Client abruptly raised up from her seat and charged toward the restroom and slammed the door. Client tried to barricade herself inside the restroom, by holding to the latch of the door. Staff was able to open the door of the restroom, although client was attempting to close it back. Client begin hitting her injured and casted leg against the floor and walls of the bathroom floor in attempt to self harm. 12:30pm Personal Restraint: Client was screaming "Don't fucking touch me" and attempting to bang her head against the floor. Staff was able to retrieve a pillow to help avoid injury from head-banging. Staff continually provided encouragement and comfort to help client. Client moved her head in attempt to bite staff. Client was trying to hit her injured leg against the floor. Client purposefully clawed at staff hand in attempts to cause injury to staff. Pt. was sweating and yelling "I am not stopping". Staff tried to de-escalate client by constantly offering verbal support. 12:38pm Personal Restraint End: Client begin to slow her breathing and becomes responsive to staff. Client was no longer trying to fight against the restraint. Client contracted for safety and agreed to not injure staff or herself. Patient Debriefing date/time: 09/23/22 1:15pm: Client was tearful as she sat on the floor, trying to to calm down with her breathing. Staff continued to assist client and asked if she needed anything (water, etc.) Client confirmed that she understood why a personal restraint had to be placed. Staff and client discussed safer behaviors that can be practiced in the future. Client seemed to be receptive of the informatoin and went back to the house with staff. Nursing Assessment date/time: 09/23/22 12:40pm: Patient presents sitting on floor in classroom from recent personal hold. Patient reports she is having trouble moving her left hand and that it is numb. This nurse assessed left hand by manual check for cap refill and less than tree seconds noted for refill. Pt sensation present at left upper extremity per Pt. Pt reassessed for hand numbness ten minutes later and left hand complaint resolved and patient performing range of movement without difficulty. Pt alert and oriented to person place time and event. Pt provided information as to why personal hold performed from her safety and the need to remain safe. Guardian was notified on 09/23/22 at 1:50pm Injuries to staff or client: Staff suffered a scratched hand. Follow-up to injuries: Staff will self care. Additional comments about this incident: Pt will need a new cast. This is being assessed by the treatment team as to when the re-casting can occur and the pt's stability to have this completed. Incident Report for same client at 3:00pm on 09/23/22 Incident Description: Self Injury (Not Suicidal), Excessive Rule Violation, Threat to Safety, Patient Injury Staff Involved: Joseph Davis-nurse, Carlos Shavers, Starkisha Watkins, Terrence McDaniel Events Leading: Client has been attempting to remove cast to right lower extremity for a couple of days. Client damaged cast by hitting on the ground, and bearing weight on it, causing an opening on the bottom of the cast. Client then took a shower without covering the cast, causing it to get wet inside. Client to be sent to ACH ER for possible recast/evaluation. Client transported via agency staff and vehicle. Notes:
