Report Description: Residents Name/DOB: Date/Time of incident: 10.16.22 10:57pm Please give a description of the incident: Per staff report last night around 10:57pm, the resident asked staff for the clippers to fix his hair cut. The resident was given the clippers and clipped his hair while in staff?s supervision. After the resident began to walk down the hallway onto the residential hall with the clipper entering multiple residents' rooms and clipping a patch of hair from 6 different resident's head. Once the clippers were given back to staff, the resident became upset and broke the plexiglass covering the television in the dayroom and tried to attack staff. Actions Taken: Resident has been placed on line of sight and peer restriction from the 6 youth. Going forward clippers will only be available to use during the weekday with management oversight. FCPD was contacted and brought onsite. The resident was detained to obtain the plexiglass from him. After the plexiglass was recovered the resident processed with staff and went to bed. All notifications have been made. Guardianship: Foster Care Placement
Interim Action Narrative: FCPD was called and resident was detained to obtain the plexiglass. He processed with staff. Resident was placed on line of sight and peer restriction.
Maltreatment Narrative: Outcome:

Licensing Narrative: Licensing Specialist will follow-up with facility. 10/20/2022 Licensing Specialist reviewed camera footage of the 10/16/2022 incident. Licensing Specialist viewed footage from 21:58 to 22:16 timeframe. The areas viewed were the 100 Hall and Station 1 (Nursing Station). Licensing Specialist observed resident playing around with the clippers pretending like he was cutting a staff member's hair. Staff could be seen talking with the resident with his hand out for the clippers. Resident then walked off and entered into different bedrooms with a staff member following behind him. Licensing Specialist could not view what took place in the bedrooms due to no cameras being located in the bedrooms. As the resident and staff member entered and left out of each bedroom that was entered, some residents came out of their bedrooms rubbing their hair. Licensing Specialist saw one resident who appeared to be in shock as though if he may have been sleeping. The resident with the clippers could be seen laughing about his behavior with another resident. Staff member was observed following the resident and appeared to be talking with him. From what Licensing Specialist observed the resident was not left unsupervised during this incident. Licensing Specialist was informed that clippers are provided to the residents who have facial hair for them to trim their faces. No licensing concerns noted.
