, Police were called: N/A Safety Plans: Suicide Risk, Self-Harm Precaution Safety plans in place for the next 7 days. On 10/29/2022, 1800, returned to the unit and found that some of her belongings had been damaged by a peer that was dysregulated. She became very upset and started banging on the door and throwing peers belongings. Shortly after, she grabbed a marker that belonged to her peer and ran down the hallway with it where she bit a small piece of the plastic part of the marker and began scrapping it across her arm. Staff support was called and plastic piece was removed from residents hand. Staff remained down the hall with resident to monitor behavior. Several attempts were made by staff to deescalate resident, but she appears to be having an episode of psychosis as she is unresponsive to staffs de-escalation techniques and continues to look for avenues to self-harm. Eventually, resident attempts to bite off light socket and is put into a physical restraint to maintain her safety. Once resident is deemed safe, she is removed from the restraint. Resident scores high risk for suicide on C-SSRS and verbalizes active plan to commit suicide with intent. Dr. Froman notified, orders received to place on strict 1:1 and attempt to transfer to acute facility if facility is able to accept. remains strict 1:1 throughout the night without further incident after the physical restraint. reassessed once awake for the day where she verbalizes that she felt she ?just had a bad night? after realizing her belongings were destroyed. She verbalizes that she was very upset but ?was not trying to hurt herself, she was just mad.? Resident scores low risk for suicide on C-SSRS scale. Dr. Froman updated on patient status and states that we can hold off on acute transfer and place her on constant line of sight instead of 1:1. Resident in good spirits throughout the day without incident. Resident remains on constant line of sight for the time being as a result of these events per Dr. Froman. Lateral scratches noted on L. inner arm from initial act with the broken marker

piece along with several smaller scratches on both inner arms from fingernails. Scratches cleaned, covering applied.

Interim Action Narrative: Resident was placed on suicide risk and self-harm precautions. She was placed on constant line of sight. Her scratches were cleaned and covered.
