**Description:**

On 3/2/22 a report was received from Arkansas DHS in regards to a new report.

The DHS snapshot was reviewed and the following is a summary of the report.

The alleged victim is [REDACTED] [REDACTED] is in Texas CPS custody and currently in residential care at Perimeter Behavioral Health of the Ozarks (Washington County, Springdale, AR). The alleged offender is an unknown staff member at Perimeter. The alleged victim refused to give name and description. [REDACTED] initially disclosed on 2/28/2022 that she was being hurt at the facility. She was asked if she was being hit and she denied it. [REDACTED] was asked if she was touched inappropriately and she said "yes". It was indicated that it was facility staff, but since staff members were in the vicinity, [REDACTED] was just asked to say "yes" when got to if it was a male or female offender. She indicated "yes" to male. [REDACTED] refused to give a name or description for the offender. No further information was given about how or where she was touched. [REDACTED] then recanted the allegation and said it was not true. She did not give any further information. [REDACTED] is being discharged from the facility due to an altercation with a peer on 2/27/2022. There has been a 7 day discharge notice. She will be picked up 3/7/2022 by Texas CPS staff. It was unknown if [REDACTED] has injuries from the altercation. A case manager at Perimeter was contacted about the concern and they were supposed to investigate it. Law enforcement has not been contacted.

She talked about a fight she had with another female in the cell but did not disclose anything else. I asked her if she had any problems with the staff and workers at Premier and she stated "no". I thanked her for talking to me and ended the interview.
