While I was filling out the runaway forms I was notified by Springdale Dispatch that one of the juveniles had been located at the Casey's General Store nearby and an officer was able to locate and transport her back to the facility. The staff advised that had been wearing a red hoodie and the other juvenile had been wearing a black shirt and green shorts.
I then finished the needed forms on scene and gathered photos for the juveniles and as I was leaving another call came in for a welfare check for 2 juvenile females matching the description of the runaways.
I proceeded to the area where officers were finally able to locate them walking through the park. When I approached the juveniles I observed that these were the same females from their photos and that red hoodie had the same black die from the sprinkler system as the victim.
initially fain ignorance and pretend that she had never heard of The Perimeter of the Ozarks and that she did not know who was.
I then placed under arrest for Terroristic Threats 1st and Communicating a False Alarm and transported her to the Springdale Jail.
When I had initially made contact with she was compliant but when I placed her in the back of my patrol vehicle she became very vocal any yelled and screamed at me making comments that she was going to get out and kill me and flailing around in the back seat kicking the door and cag attempting to break the window and Plexiglas dividers.
Once back at the Springdale Jail I filled out the booking sheet and then turned her over to the Jailers for processing.
While I was working on the preliminary report to send to Washington County Juvenile Detention Center I was notified by the Jailers that was continuing to be belligerent making similar threats to the jailers that when she gets out that she was going to kill them and throwing chairs around the holding cell.
Officers had to assist the jailers in getting back into handcuffs for transport and when she was placed into the transport van she spit onto one of the jailers. Therefore an additional charge of Aggravated Assault upon a Law Enforcement Officer was added to
