On 4-5-2022 at approximately 5:07pm I, Officer Mansel made contact with the complainant Pasonna Hope at the station for a battery report. Ms. Hope stated that she was one of the directors at Perimeter Health for juveniles on Albert street and had a staff member [REDACTED] assault one of the juvenile residents. Ms. Hope stated that she watched the surveillance camers and saw [REDACTED] pick up resident [REDACTED] and slam him on the ground out in the court yard. Ms. Hope stated that other staff members attempted to shield [REDACTED] from [REDACTED] but he was ignoring them. [REDACTED] was then seen going after other residents who had tried to hit him during the altercation. [REDACTED] was then taken into the administration building where he then left refusing to give his access key back.
An affidavit has been filed by Director Charlotte Lockhart for battery 3rd.
