On May 9th, 2022, I, Officer Hallmark was dispatched to Perimeter of Behavioral Health at approximately 11:48pm. The nurse Amy called stating that they had four juveniles run away from the facility. She stated there were two white males, one Hispanic male, and one black male. She also stated that they had on extra clothing underneath the clothes they were wearing so she was unable to give a clothing description and was also unable to give a direction of travel.

Upon officers arrival I was met by Nurse Amy. I asked her what had occurred. She stated that one of the juveniles gave one of the female staff members a hug. While he was hugging her, he took her keys off her lanyard. She stated that the staff member asked for her keys back the juvenile gave her keys back but not before taking the key fob for the doors off. Mrs. Amy stated that the boys then used the staff members key fob to exit the back door and ran away. Mrs. Amy stated that the staff member didn't even notice the key fob was missing till the boys had already left the facility.

Mrs. Amy was able to give me the names and date of births of the four juveniles that ran away along with legal guardian information. Black male

(16 years old) from Ohio legal guardian is Dona Arnold, CNC, Hispanic male (14 years old) from Texas legal guardian is Melissa Marinez, CPS, White male (16 years old) from Texas legal guardian Ceanne Spence, DFPS, and Unknow race male (15 years old) from Montana legal guardian Sarah Fry, OPHHS-CPS. The juveniles have not been located at this time.

The juveniles were entered into ACIC as runaways.
