The caller stated they had a resident that was assaulting staff members Upon arrival I made contact with the suspect and identified her as I noticed was yelling as several individuals were restraining her. I noticed four staff members were attached to each limb of to keep her from moving around. yelled that she gets triggered when people touch her due to being raped in the past. I attempted to speak with , but she was very agitated. After a few minutes I was able to get ______ to calm down. I asked the staff get off of her if she would speak with me. I asked the staff to stop restraining her. I spoke with and asked her what had happened. stated one of the triggers of her trauma is the smell of smoke. stated she was telling the staff about the smoke but they did not do stated she yelled at them not to touch her as that's stated she became agitated and was yelling at the staff. stated the staff proceeded to touch her despite her telling them not to. another trigger for her. from the staff but they restrained her by having everyone jump on her. people to restrain individuals who misbehave. I then spoke with the staff members who were injured by Library I spoke with Darian McNeill (W/M DOB 2/18/93) and Jason Golden (B/M DOB 9/16/94) both McNeil and Golden stated they responded there to assist the other nurses as was upset. McNeill stated he checked the room was at and could not smell the odor of smoke she was complaining of. Both of them stated attempted to jump into the nurse station. Both Golden and McNeill stated they proceeded to restrain where she kicked punched both of them. McNeil stated he wished to press charges. Golden stated he wanted to press charges at first but then he stated he did not. I did not observe any injuries on wither Golden or McNeill. again and she stated she wished to press charges on Golden and McNeill for "touching her" had been admitted to this behavioral unit for treatment. I believed, as she was now calmed and cooperative, she no longer posed a threat to staff and she could continue being treated at the facility. was consoled about her behavior. I took the information for the report and ended my contact with narrative, JR329.

I then called Ozark Guidance Center and spoke with Anne Sheetz and she was not able to locate anyone with the name of Sheetz checked the discharge paperwork and was not able to locate anyone with the name of Sheetz stated that she will check again and if she locate she would call me back.

At this time the reporting officer interviewed all the parties involved and as per the investigation, I will forward this case to Washington County Juvenile Prosecutor Attorney for review.
