A/v is [REDACTED] is currently at Perimeter Behavioral of the Ozarks in Springdale. A/o is an out of home offender/staff member [REDACTED]. Last night, [REDACTED] reported that [REDACTED] has crossed boundaries with her. She stated that he grabbed and touched her butt. The reporter thinks this was for sexual gratification. The reporter believes this happened more than once and it happened within the last couple of days. The touching was above her clothing. The facility is going to conduct their own investigation. [REDACTED] has been sent home on leave until the investigation is complete.

#### Description:

On 06/08/2022, Inv Chiddister interviewed [REDACTED] the interview was recorded. In summary, Inv Chiddister built rapport and discussed family dynamics. During rapport building, [REDACTED] stated that she has been at Perimeter since 04/21/2022. [REDACTED] stated that before that she was in Springwoods and before that she was at home with her family. Inv Chiddister asked [REDACTED] about getting in trouble when she was at home. [REDACTED] stated that whenever she would get in trouble her parents would take away her phone. [REDACTED] was asked about food in the home. [REDACTED] stated that there is plenty of food in the home. [REDACTED] was asked about the reason that she was being interviewed today. [REDACTED] was asked if it was about the staff member here at Perimeter. Inv Chiddister asked [REDACTED] who the staff member is. [REDACTED] said that his name is [REDACTED] and she doesn't know his last name. [REDACTED] stated that [REDACTED] is a lead. [REDACTED] was asked the reason that inv Chiddister would be here because of [REDACTED]. [REDACTED] said that [REDACTED] had touched her inappropriately. [REDACTED] said that she thinks that [REDACTED] might have done the same thing to other residents but doesn't know for sure. [REDACTED] was asked when the last time [REDACTED] had touched her. [REDACTED] said yesterday. [REDACTED] was asked where this happened. [REDACTED] said that it happens anywhere. [REDACTED] said that no one notices and everyone loves [REDACTED]. [REDACTED] said that everyone acts like it's [REDACTED]. [REDACTED] was unable to provide any detail on yesterday when [REDACTED] touched her. [REDACTED] stated that she remembers the incident the day before. [REDACTED] was asked about what happened the day before. [REDACTED] had stated that she needed to process and [REDACTED] took her off of the unit and onto the educational hallway. [REDACTED] stated that this was after dinner and in between shower time and med pass. [REDACTED] said that dinner is at 5:30 and lasts for thirty minutes. [REDACTED] stated that she and [REDACTED] were the only two on the education hall. [REDACTED] was asked about needing to process. [REDACTED] said that she needs to process a lot and she processes with other staff members as well. [REDACTED] stated that [REDACTED] always takes her to the education hallway. [REDACTED] was asked if the education hallway is off of the unit. [REDACTED] stated that you leave the units, go past the nurse's station, and then go through some doors to enter the education hallway. [REDACTED] confirmed that there was no one else on the education hallway. [REDACTED] said that she doesn't remember what she needed to process. [REDACTED] was asked what happened next. [REDACTED] said that after she and [REDACTED] process [REDACTED] always ends up hugging [REDACTED]. [REDACTED] stated that when [REDACTED] hugs her he touches [REDACTED] on the ass or my tits. [REDACTED] said that she never says anything because it happens all the time. [REDACTED] said that she didn't want to get [REDACTED] in trouble because everyone loves him and everyone says that [REDACTED] can be trusted. [REDACTED] stated that she doesn't want [REDACTED] to have to leave. [REDACTED] said if that happened she would feel like it was her fault. Inv Chiddister asked [REDACTED] where she and [REDACTED] were at in

the education hall. [REDACTED] stated that she and [REDACTED] were sitting on the floor across from each other by the door from the hallway to the unit with their backs against a wall. [REDACTED] said that after they are done processing they stand up and that is when [REDACTED] gives [REDACTED] a hug. [REDACTED] was asked about [REDACTED] touching [REDACTED] on the ass. [REDACTED] said that [REDACTED] uses his hand and rubs her ass on top of the clothes when he is giving [REDACTED] a hug. [REDACTED] said that [REDACTED] didn't touch her on the tit that day but he has touched her on the tit before. [REDACTED] was asked if [REDACTED] said anything to her. [REDACTED] said no and that [REDACTED] never does say anything. [REDACTED] was asked about [REDACTED] touching [REDACTED] on her tit. [REDACTED] said that it's always on top of the clothes and [REDACTED] uses his hand. [REDACTED] said that time [REDACTED] will rub her tit and other times his hand will stay still. [REDACTED] stated that [REDACTED] never says anything when he touches [REDACTED] on the tit. [REDACTED] was asked if this always happens on the educational hall. [REDACTED] said that this also happens on the unit and at the nurse's station in plain sight. [REDACTED] said that no one pays attention because it's [REDACTED]. [REDACTED] was asked how it makes her feel when [REDACTED] touches her on her ass and tits. [REDACTED] stated that she has no boundaries because everyone crosses her boundaries. [REDACTED] said that at first it didn't bother her but it kept building up. [REDACTED] stated that at first, she had boundaries with [REDACTED]. [REDACTED] stated that she doesn't trust men and usually doesn't talk to men. [REDACTED] said that with [REDACTED] it was different. [REDACTED] said that it made more sense when [REDACTED] started doing the things that he did. [REDACTED] said that [REDACTED] took advantage of her because [REDACTED] knew that [REDACTED] was hypersexual and easy. [REDACTED] said that [REDACTED] thinks he could get away with it. [REDACTED] said that was why she never said anything at first, but it got to the point that she was going to explode and needed to say something. [REDACTED] was asked how often this would happen. [REDACTED] said this has happened multiple times a day over the past three weeks. [REDACTED] was asked if anything happened when she first came to Perimeter. [REDACTED] said no. [REDACTED] said that she would never talk to [REDACTED] but one day she needed to process and [REDACTED] was the only one who was available. [REDACTED] said that she processed with [REDACTED] and everything went well. [REDACTED] said that she continued to process with [REDACTED] because she felt comfortable talking to [REDACTED]. [REDACTED] was asked about the first time that [REDACTED] touched her. [REDACTED] said that this happened on the green unit. [REDACTED] said that [REDACTED] touched her on her side by her waist. [REDACTED] stated that [REDACTED] got more touchy as time progressed. [REDACTED] said that [REDACTED] will sometimes move his hand down her side and sometimes will move his hand towards the front. [REDACTED] said that sometimes [REDACTED] will touch her on her side by her tit. [REDACTED] was asked to describe the hug. [REDACTED] said that sometimes it's a front hug. [REDACTED] said that sometimes it's a side hug and moves into a face to face hug. [REDACTED] stated that they are only allowed to give side hugs. [REDACTED] was asked if anyone has seen [REDACTED] give her a front hug. [REDACTED] said that she isn't sure but the cameras would have seen it. [REDACTED] was asked if she has ever seen [REDACTED] give other residents front hugs. [REDACTED] said yes, but she can't think of any names. [REDACTED] was asked about the touch on the ass. [REDACTED] said that [REDACTED] will start on the side or the back and his hand will move down to [REDACTED] ass. [REDACTED] was asked if she has ever said anything to [REDACTED] when this happens. [REDACTED] said no. [REDACTED] was asked if [REDACTED] has ever asked her to touch him. [REDACTED] said no. [REDACTED] was asked if any part of her body touches him when she they hug. [REDACTED] said that she usually has her hand and arm around [REDACTED] side and his back. [REDACTED] was asked if she had just recently told someone about this. [REDACTED] said that she reported this to a nurse. [REDACTED] said that she reported the same thing to the nurse. [REDACTED] was asked if she knows how [REDACTED] is. [REDACTED] said that [REDACTED] is in his late 20's to mid 30's. [REDACTED] said that he is tall and African-American. [REDACTED] was asked about [REDACTED] processing with other residents. [REDACTED] said that everyone processes with [REDACTED]. [REDACTED] said that [REDACTED] usually takes them to the comfort room to process. [REDACTED] was asked if she has ever seen [REDACTED] take any other residents to the education hall. [REDACTED] said that she has seen him take anyone else there but isn't sure if he has. [REDACTED] was asked about other staff processing with her. [REDACTED] said that sometimes they will go down the hall on the unit or to the comfort room. [REDACTED] said that they usually process one on one. [REDACTED] said that there are other people around but they aren't right there listening in. [REDACTED] said that [REDACTED] is the only one who takes her where no one can see them. [REDACTED] said that the other staff give side hugs. [REDACTED] was asked if [REDACTED] has ever shown [REDACTED] any special treatment. [REDACTED] said no. [REDACTED] was asked if this was alright with her. [REDACTED] said that it was a don't speak about it type of thing. [REDACTED] said that she knew it wasn't ok. [REDACTED] said if she didn't talk about it then the both of them wouldn't get in trouble. [REDACTED] said that [REDACTED] would lose his job and [REDACTED] wouldn't get put on sexual restriction. [REDACTED] was asked if [REDACTED] seemed different when he would touch [REDACTED] on the ass or tit. [REDACTED] said that [REDACTED] seemed all lovey-dovey. [REDACTED] was asked if [REDACTED] ever touched her on the ass or tit when they would side hug. [REDACTED] said yes. [REDACTED] was asked about feeling [REDACTED] body when they would hug. [REDACTED] said that she would only feel his body when they would front hug. [REDACTED] said that [REDACTED] would have his hand on her ass and [REDACTED] would pull [REDACTED] into him and she could feel his area. [REDACTED] was asked if she could feel anything. [REDACTED] said that [REDACTED] had a boner every time. Inv Chiddister began to introduce a male anatomical drawing to get clarification on what [REDACTED] meant by area. [REDACTED] stated that [REDACTED] dick was hard. [REDACTED] confirmed that area was [REDACTED] dick. [REDACTED] was asked how often [REDACTED] gave her a front hug. [REDACTED] said about three or four times. [REDACTED] said that each time [REDACTED] had a boner. [REDACTED] said that one time she was talking to [REDACTED] about her hypersexuality and her impulse control. [REDACTED] had told her that sometimes we have to walk around with two pairs of basketball shorts on so you all don't see anything. [REDACTED] said that she knew that [REDACTED] was referring to himself. [REDACTED] said that [REDACTED] always has basketball shorts under his scrub pants. [REDACTED] said that [REDACTED] pants sag. [REDACTED] was asked about [REDACTED] working on the unit. [REDACTED] said that [REDACTED] is a lead and doesn't work on the unit but does come on to the unit. [REDACTED] was asked if anyone else has ever touched her in a way that wasn't alright with her. [REDACTED] said yes and that has already been reported. [REDACTED] made no other disclosures of sexual abuse/abuse/neglect.

**Description:**

I went to Perimeter Behavioral Health, and made contact with the Director of Nursing, Julie Sizemore. Julie escorted me to a room which contained their camera equipment and computer. She was able to show me the camera footage, from the most recent incident that [redacted] referenced. At approximately 2100 hours, [redacted] and [redacted] walk into the, "Educational Hallway." There they sit, facing each other, next to the door. They are seated, on the floor, with their legs extended, and feet touching the others feet. They sit like this, and talk, for several minutes. At approximately 2120 hours, they stand up, and hug.

The hug is a front to front hug, and [redacted] arms are above [redacted] shoulders. When they hug, [redacted] leans into [redacted] until their faces are touching, he takes his right hand, and places it straight onto [redacted] rear end. [redacted] is so much taller than [redacted] that he has to lean over, and stretch his arm out, significantly to reach her rear end. Upon seeing the video I immediately thought the hug looked unnatural, and, with his height compared to hers, it appears the strategy of the hug was so he could reach her rear end. I asked Julie about the facility's policy on hugging. She said their policy is, "Side hugs", only. Front to front hugs are not permitted.

I then began asking Julie about [redacted] and [redacted]. She stated they have not had any issues with [redacted] and everyone seems to like him. She said this was the main reason [redacted] didn't want to come forward, out of fear that that there would be retaliation by other students or staff if [redacted] was fired because of her.

She then stated they have noticed a change in [redacted] behavior over the past three weeks. One issue they noticed was [redacted] increases in self harm. Due to this she had been moved to a program that provided closer observation to the residents.

I asked about [redacted] disclosures with staff that led to the investigation. Julie identified two staff members, who [redacted] had spoken to, and told me I could speak with them while I was there. The staff members were identified as Lukysha Neal and Sarah Kroon. I spoke with Lukysha first.

She, first, described their method of, "Processing", which the children speak privately with a staff member. She said, yesterday 6/9, [redacted] asked if she could process with her. She could not do it right then, so, throughout the day, [redacted] reminded her two more times that she wanted to process. She,

then, realized that [REDACTED] must really want to talk to her, so she brought her in for the meeting.

They went to Lukysha's class room, and began the meeting. [REDACTED] wanted Lukysha to know about what was going on between her and [REDACTED]. Lukysha then began taking notes. [REDACTED] stated that, approximately three weeks ago, she and [REDACTED] were outside the, "Green Unit", processing. [REDACTED] stated they were talking about boundaries and impulses. [REDACTED] informed [REDACTED] that she has no boundaries. Lukysha went on to say that [REDACTED] is hypersexual, has no boundaries, and has made that known from the beginning of her stay there. During the processing, [REDACTED] asks [REDACTED] what she does when she has the impulses. [REDACTED] says she does stuff with her hands and stays busy. [REDACTED] then tells [REDACTED] that its okay to act on her impulses. Upon hearing this [REDACTED] touches [REDACTED]. "On parts of his body." [REDACTED] then expresses to Lukysha that she doesn't want to go on, "Red sheet." Lukysha explained to me that red sheet is just a safety precaution. [REDACTED] said she doesn't want to go on red sheet again, but wanted to tell someone about the situation.

Lukysha further explained what [REDACTED] said about touching [REDACTED]. She stated, "She groped his private area, and there was some stimulation. Some arousal that was going on. When she said she did it he said, "No foul I'm not going to say anything"."

Lukysha also told me about staff members are already confronting [REDACTED] about the situation, because [REDACTED] was such a beloved staff member. Lukysha was also confronted about her processing with [REDACTED] by other staff members. I asked if [REDACTED] told Lukysha which staff members were confronting her. She confirmed that [REDACTED] did, and she turned those names in.

When they were done speaking, Lukysha escorted [REDACTED] back to her room, and Lukysha went to talk to Julie and the case manager.

I thanked Lukysha for speaking with me, and ended my contact.

The second staff member I spoke to was Sarah Kroon. Sarah identified herself as one of the facilities nurses. Sarah stated that [REDACTED] wanted to process with her. During the processing [REDACTED] was anxious, and stated she was scared to tell Sarah what happened. [REDACTED] then stated that she had crossed a boundary with one of the staff members, and he crossed a boundary with her too. Sarah stated that [REDACTED] was scared to tell her what happened, but she was giving hints of who it was. She eventually told her it was [REDACTED] told her where it happened, and told her an exact time and date of when it happened. Sarah reviewed the camera footage, observed the incident, and noticed that [REDACTED] was, "Spot on." Sarah turned the information in to Julie.

I asked Sarah if she knew about any other incidents between the two, and she said [REDACTED] had told a lot of staff members about her touching [REDACTED]. However, [REDACTED] stated that incident probably wouldn't be on camera, because they were outside and facing away from the camera.

Sarah said that [REDACTED] told her situations like this happen all the time, but she knew of this exact date and time, so they could look at the cameras.

██████ told Sarah she couldn't tell her exact dates and times of other incidents, but, since this was the most recent, she could for this incident.

I asked why ██████ wanted to process with Sarah, and she said they process together a lot. She told me that, leading up to the disclosure, ██████ was attempting to process with her for three days, but Sarah was too busy.

I thanked Sarah for speaking with me, and ended my contact.

My interviews with Sarah and Lukysha were recorded using a voice recorder.

The facility CEO requested a subpoena from me, to release the footage. I acquired one, presented it to him, and he provided me with a flash drive, which contained footage from the incident.

### Description:

On June 17, 2022 at approximately 0830 hours [REDACTED] came to the office to be interviewed. I began by asking [REDACTED] for basic information, and I read him his Miranda Rights. He signed the form, stating he understood his rights, and verbally agreed to speak with me.

I began by telling him that I was speaking with I'm, as a result of allegations made against him by a resident of Perimeter Health. I then asked him if he knew what the allegations were. He stated he did, and it was because he had touched someone during a hug.

He explained that, several weeks ago, he was called by the director of nursing, and she explained to him that he had to go home. He asked why, and she just said it was a, "Boundaries", issue, and they were turning it over to a higher power. He later found out it was because he touched someone.

He explained to me that he has children, he loves his job, he had recently had a promotion, so he would not do anything to put his employment in jeopardy. He then began describing the situation with the girl. I asked if he knew the girl, and he identified her by name.

He described to me that everyone there knows [REDACTED] is hypersexual, and has done things in the past with the staff. He stated she, sometimes, acts on impulse, and touches staff inappropriately. He told me that, to protect himself, he always processes with the children in front of a camera.

He then began telling me about the incident that led to the investigation. He stated he was processing with [REDACTED] and she was talking to him about dealing with her impulses. He then stated that he allowed to give, "Side hugs", when dealing with the children. That day, with [REDACTED] he leaned in for a side hug. He said, "I went down, I got long arms, and I came right back up, and that was it."

I asked him to further describe the hug. He stood up, and began demonstrating what he did. He stood up, demonstrated a side hug, which he put his right side towards her, leaned over, and gave her a hug. I asked him how long the hug lasted, and he said it didn't last long at all. I asked if he touched her butt at all, and he stated he didn't even think he touched her. He stated several times he didn't think he touched her butt, but if he did it was accidental. He also described to me several times that the hug was very brief.

He further went on to say that [REDACTED] has inappropriately touched some of the staff, so I asked if [REDACTED] had ever touched him. He denied. I, later, questioned him about the situation [REDACTED] described where she touched him on the crotch. I first asked if he remembered processing with her outside, and he denied. I asked if he ever takes the children outside to process, he stated he does, and there's a camera out there. He stated he hasn't taken [REDACTED] outside, but if he did it was only one time. I informed him of what [REDACTED] had disclosed, and asked him if that happened. He adamantly denied this, and stated that never happened. He did state that he could tell she was coming onto him, but she never acted on it. He continued denying, and I asked him why she would say something like that. He then alluded that, when they hug, they may accidentally touch, but there was nothing intentional.

I then asked about him being aroused while giving her a hug. He adamantly denied again, and stated that it was just side hugs. I also asked about the situation [REDACTED] described about him wearing basketball shorts under his pants. He stated that he does wear shorts under his pants, one time he bent over, [REDACTED] saw his shorts, and asked him about them. He responded to her by saying that's not a question she needed to ask him.

I, again, questioned him about the side hugs. He explained to me that they have to do side hugs, because front hugs are not allowed. I asked if he ever gave [REDACTED] a front hug, and stated one time he did because she was crying. I asked if he ever did a side hug, and [REDACTED] gave him a front hug. He stated she did.

He reiterated that he has never grabbed her inappropriately, and wouldn't risk his job like that. He went on for several minutes stating he has not once grabbed her butt or her breasts. He stated she only reported him because she's mad at him for calling her out. Which, initially, he stated he didn't know why she was doing this, but, halfway through the interview, he started saying she was mad at him for calling her out on her touching other staff.

He continued describing the hug, and stated he never grabbed anything. He stated he may have accidentally grazed her butt, but did not hold his hand there. He then stated there's no way she could have felt if he was aroused or not, because he only gave side hugs.

I told him that I watched the video, and the hug was longer than he described. He said that sometimes the hug lengths vary.

In conclusion, out of his, many, descriptions and demonstrations of the hug none of them corresponded with the video footage I had observed.

I thanked [REDACTED] for speaking with me, and ended the interview.
