Description:

BWC was active.

At approx. 10:41 P.M. on 31 July 2022 I, PTL Samuelson, responded to Perimeter of the Ozarks on 48th street for a battery report. It was reported a patient assaulted a staff member.

I arrived and made contact with staff member Stephanie Figueroa (4/3/1994). She is employed as a medical tech for the facility. She said that [REDACTED] is a patient and was acting up. Staff member Menkara York (2/22/1999) attempted to restrain her and Stephanie saw [REDACTED] kick him in the face. Stephanie stepped in to help. Stephanie tried to help grab her legs and was kicked in the head. [REDACTED] managed to grab the back of Stephanie's head and remove some of her hair.

Stephanie showed me a ball of her hair. I asked her to show me where it was pulled from the back of her head, and I saw a patch where the hair was removed. I also later noticed a small cut where her glasses sat on her nose; Stephanie said that her glasses were pushed into her face during the altercation. Stephanie requested to press charges.

I next made contact with Menkara who was watching [REDACTED]. [REDACTED] was seated in the hallway. Menkara said that she was acting up and did kick him. He did not want to press charges; he said it was good enough that Stephanie was.

[REDACTED] did not make a statement when I asked what happened, she said it didn't matter. I contacted JDC intake officer Kelly Shelton who advised that [REDACTED] would be held at JDC until her court date the next morning. I later noticed [REDACTED] had a fresh cut on her knuckle.

I placed [REDACTED] under arrest for Battery 2nd on a health care worker and transported her to the Springdale P.D. Once the preliminary report was completed jailors transported her to the Washington County JDC.
