She advised she told her friends who then told staff and she was brought into the conference room and asked about the incident. Latisha everything. The forensic interviewer asked about the gifts received and she advised that he would let her use his vape and would take her off the unit. The forensic interviewer asked who the staff member was and advised that it was and his full name was would give everyone nicknames and hers was "Snow White". The forensic interviewer then asked what she meant about the incident occurring three to four days and disclosed that asked her to help him with hydration where she was not allowed to be but she went and he kissed her. disclosed that the first incident occurred when the suspect asked her to help him with fill up the water coolers in the kitchen; she advised he kissed her on mouth and slid his hand up her shirt and touched her breasts. She described the room as being really dark and him initially having his cell phone flashlight on but him turning it off. described the place as being in the kitchen where there was "big deep sinks" and a flat area where they put their trays on after eating. disclosed that on the second incident (the next night) stuck his hands her pants and rubbed her vaginal area and penetrated her vagina with his finger. disclosed he was rubbing all over and everywhere and he "fingered" her. advised that she stepped him (he was standing in front of her) and he stopped. advised she put her hands on his arms and pushed back away from him. advised that she stepped back away from disclosed that on the third incident, had asked her if she wanted to help him do "med pass" and she said "yeah" and he told her they had to fill up hydration. She advised the first time he dumped the water out and put ice and let the water go "really slow". She advised that it happened really fast when he kissed her and turned her around and put his hands down her pants and put his finger into her vagina and then proceeded to pull his pants down and bent her over and penetrated her vagina from the behind with his penis. advised she heard his zipper and he "put it inside" her, the forensic interviewer asked what "it" was and disclosed that "it" was his penis. She advised he grabbed her hair while she was bent over and pulled her head up and her hands were on the railing of the sink and that she could see her shoes and a little bit of his leg. The forensic interviewer asked what made him stopped and she advised that the water was getting full and he stopped and he told her to fix her hair and they went out and she set up the cups.

disclosed that on the fourth incident (same day as the third) that her and took two coolers downstairs to fill up for hydration and "he just turned me around and did it all over again". She advised that "he eventually pulled back and was like get on your knees" and was pushing her head down and she put it in her mouth and he put her hands on it. She advised she got up and he turned her around again and he "did that again". She advised he stopped and turned the water and filled up the hydration up.  advised that it hurt and the forensic interviewer asked where it hurt and she said her vagina hurt. She advised that she went back to her unit and "there was blood everywhere" and when the forensic interviewer asked where advised "like on my underwear and shorts" and said "it hurt".  advised that at one point she told "that really really hurt" and he said "I'm sorry" and he kissed her on the neck and "started back again". She advised they had sex on August 17th, 2022.
In short, advised turned her around and penetrated her again in the vagina and then told her to get on her knees and penetrated her mouth with his penis. She advised he ejaculated in her mouth before turning her around again and penetrated her vaginally again before ejaculating a small amount in her vaginal cavity. She advised once she was back on the unit she ran cold water over clothes to get the blood off, and that after he came in her mouth she wiped her mouth on her shirt.
Due to who is currently employed at Perimeter Behavioral of The Ozarks (2466 S 48th Street B, Springdale, AR) and is responsible for the care and custody of the juvenile females and being in a position of trust and authority over the victim by being a caretaker of and sexually assaulting her on three separate occasions, I am charging with three counts of Sexual Assault 1st (5-14-124).
Due to touching on her breasts, I am charging him with Harassment (5-71-208).
Due to Due to allowed her to use his vape on previous occasions. I am charging him with Providing Minor with Tobacco products (5-27-227).
I am also charging with Endangering the Welfare of a Minor 2nd because he knowingly engaged in conduct creating serious harm to the mental welfare of the who is being treated for sexual tendencies and self-harm.

Registered Nurse O'Malley advised that there was genital finding and bruising to the hymen in three locations.

On Tuesday, August 30, 2022 at approximately 10:15AM, I reviewed the file sent by Registered Nurse O'Malley via email.

The file stated in the additional comments: "#1 healed hymnal transection/missing segment from 8-9 o'clock with acute bruising to the area from 8-9 oclock of the hymen. #2) healed missing segment of hymen from 4-6 o'clock, with acute bruising present from 4-5 o'clock to the area on the hymen. #3) Acute bruising to the hymen from 1-2 o'clock".

The file stated in the exam summary: "Expected female referred for acute medical forensic exam related to disclosed sexual assault. Healed finding are note to the hymen – not forensically significant due to prior sexual history. Acute bruising is also noted to the hymen – evidence of penetrative trauma of the vulva – recent".

The file stated in the non-fatal strangulation event history: "He grabbed my throat while he was making out with me. He just kept squeezing my throat".
