The 15 year old juvenile victim identified as [REDACTED] disclosed that a staff member who she identified as [REDACTED] who is currently employed at Perimeter Behavioral of The Ozarks and is responsible for the care and custody of the juvenile females who reside in the facility had sexually assaulted her on two different occasions.

[REDACTED] advised she had been at Perimeter since April 21, 2022 and advised she was being treated for trauma, hypersexual, and suicidal ideations.

Do you know why we are here to talk to you today and the [REDACTED] advised that it was probably about the " [REDACTED] situation".

The interviewer asked her what the " [REDACTED] situation" and [REDACTED] advised that she and Mr. [REDACTED] got close and played chess together and he would take her off the unit to process and would ask if she wanted to go off the unit to process. [REDACTED] advised that it was red flag because staff would not ask the juveniles because the juveniles were supposed to ask staff if they needed off the unit.

[REDACTED] asked that she had asked [REDACTED] to process of the unit because she had been triggered by something that occurred that day.

[REDACTED] advised she told [REDACTED] that she was "feeling impulsive" to act on her sexual impulses and self-harm impulses. She advised he asked her impulses towards but she refused to tell him. [REDACTED] advised that he automatically thought it was about him asked if she wanted him to encourage her impulses or stop her impulses. [REDACTED] advised he went to fill up the "hydration" and came back to the YCC office and there was no one in the nurse's station. [REDACTED] advised once he came back he said that she was lying to him because that was her chance to act on her impulses, and that she wouldn't have gotten into trouble. [REDACTED] advised that [REDACTED] told her he would encourage her impulses.

[REDACTED] advised [REDACTED] was sitting inside the office and she was sitting outside the office when he pulled his "dick out" and he asked her how she was feeling. [REDACTED] advised that the cameras were covered with suitcases.

[REDACTED] advised that after they went to check on the other staff members on the floor before he returned and he told her to go into the YCC office where they "made out" with [REDACTED] gave him a "hand job". She advised afterwards she went back to her unit and they played chess.

[REDACTED] advised that she told Madeline her counselor about the incident involving [REDACTED]

The interviewer asked for more specific details the second incident and [REDACTED] disclosed that she gave him a "hand job" which she described as putting her hands in his pants while his pants were partly down and touched his penis with her hand. [REDACTED] disclosed the penis was hard while she was giving him a "hand job".

[REDACTED] defined "making out" as her and [REDACTED] kissing and him touching her butt.

Due [REDACTED] exposing his penis on the first incident to [REDACTED] I am charging him with Public Sexual Indecency (5-14-111).

I am further charging [REDACTED] Sexual Assault 2nd (5-14-125) due to him being a mandated reporter in a position of trust over [REDACTED] and engaged in sexual contact with [REDACTED]

I am also charging [REDACTED] with Endangering the Welfare of a Minor 2nd (5-27-206) because he knowingly engaged in conduct creating serious harm to the mental welfare of the [REDACTED] was being treated at Perimeter for trauma, hypersexual, and suicidal ideations prior to the incident involving [REDACTED]

[REDACTED] disclosed there were two other incidents that occurred at Perimeter while she had been there.

The incident involving the other male staff member was reported previously and investigated by Springdale Police Department and State Police.

[REDACTED] disclosed that the female suspect was name [REDACTED] but advised that it was not as bad as the incident involving [REDACTED] or [REDACTED]

[REDACTED] advised it started with [REDACTED] putting her hand on [REDACTED] knee, thigh, and [REDACTED] let her go further but it was always on top of the clothes. [REDACTED] advised that she "rubbed her vagina" and that it happened all the time when [REDACTED] was at work. [REDACTED] advised that it would happen at the staff table in the dayroom.

Due to Perimeter refusing to release the [REDACTED] last name and date of birth, I spoke with Washington County Prosecutor's Office and was provided with two subpoenas, one for 90 days' worth of video footage and one for [REDACTED] information.

I provided Michael Hinton with the two subpoenas for the abovementioned requested information.

On Friday, September 9, 2022 at approximately 1:00PM, I (Detective E. Detter #393) reviewed the photos I had received from [REDACTED] via a text message. [REDACTED] advised they were from [REDACTED]

The following are what was wrote on the letters:

"Why the fuck do you keep saying "no" or shaking your head? Im doing better for you. Causing zero problems. I want you. All Im asking for is one time. ONE. Just give me a chance. How can I convince you? Name anything and I'll do it. Name something. Please. I understand you don't want to lose your job. You won't ! because I've told you. Nobody will know. Give me a chance! You can even make it like a longterm goal... (weeks or a month). and if I do it... then let me act on my impulses. Please. Just tell me what I have to do. As I said... Anything."

" [REDACTED] 6/11/22

I still don't understand how or why you think it is my fault that precautions are higher. Why rules are more strict... I told on [REDACTED] because he made uncomfortable when he was touching me in the way he was . he was holding my ass and holding my boob when he would give me hugs. he would pull me in close to him (by my ass) and I was close enough that I felt his boner. It made my very uncomfortable. You say it is my fault because I told on him for his poor boundaries ... but I constantly have poor boundaries. I am in this mental facility to work on my boundaries . [REDACTED] is a grown ass man. He "

"Should be aware of the fact that I have poor boundaries. I acted on one of my impulses he should've stopped me , and (unreadable word) me up. but he didn't say anything at all. I am working on my impulses. I crossed his boundaries because of my poor boundaries. But [REDACTED] is an adult, if he has problems with his boundaries and impulses , he shouldn't work at a place where kids are working on them. a trauma facility. Its not (unreadable word) to the kids. You"

" I cannot stand whatever the hell you're doing. Yes , I made... [REDACTED] get fired. You say its my fault. Okay, Honestly. If it is (unreadable word) isn't my fault, I don't care anymore. I just want you back. I hate that you basically ignore me... and when we talk, all it is, is "that's on you" what happened with [REDACTED] is your fault. Honesty, whatever makes you happy. I just want things to go back to the way they were between us. I can't stand not having you around. You mean so much to me. You were my everything.. and just like that ... you're gone . you ghosted me (basically) please (unreadable word) I'm sorry. I love you. I just want you back. Please! [REDACTED]"

"I don't like having to spend all my days without you. [REDACTED] i miss you. I don't want to love you. But honestly, I feel like i've already lost you. I can't stand seeing you every day, and for you not to be a part of my day... it sucks. Like i told you. i'd rather have the negative energy from you than fake energy. i'd rather see you every day and you ignore me than to not to see you period. but i honestly just want things to go back to how they were before . i miss you so fucking bad. you can't keep ignoring me, and shutting me out. [REDACTED] i am so close to shutting down, and i really need you right now. i don't want to continue to go without you. i tried my hardest...for you. i keep going.. for you. [REDACTED] (marked out "I keep going for you, and) if you aren't here... what the hell am I supposed to live for? Who the hell am I supposed (marked out "to") live you in understand I messed up... bout can't hold that against me forever. Please don't (unreadable word). I can't go my whole stay here without you. even though you are upset with me right now. please just put it away. Its in the past. i cant keep going on without you. please forgive me [REDACTED] i'm trying my hardest not to shut down . please (unreadable word) think (unknown word) it. i didn't say anything about you. love you . [REDACTED]"

You're back I missed you. the other youu sucks asshole btwim sorry for the shit I caused . I love you do you at least see where Im coming from in the situation? See where you are coming from."

"Come on, Please [REDACTED] Im begging you. Just once. Make out with me. I want you so fucking BAD. you aren't gonna lose your damn job. Just say need to lock doors or something; go in the room... I'll follow you. Make out with me. Nobody will know. It won't be obvious. PLEASE you wont lose your job."

Only person o know who did a grievance is [REDACTED] from orange she has two papers filled out [REDACTED] took hre out to put in the box" "all the girls like you so that's what shocks me who could have done it on you tho" "Well I'm just shocked because u haven't had any problems ya know. Unless they don't want me there anymore" "Why wouldn't they want you"

So will definitely be discontinued" "Well we gonna get talked to most likely cuz I was doing it too and [REDACTED] stsrtd wanting to do the same shit and she got made cuz [REDACTED] kept asking" "Shit went down Today [REDACTED] and [REDACTED] almost jumped me" "Yeah who's gonna talk to us? That makes me nervous. I held [REDACTED] and think [REDACTED] too. Oh shit! Those two are something else. What happened?" "Hey you Good?" "Lol I'm fine. You?"

I asked her if she worked at Perimeter when [REDACTED] was employed there, and she advised she did know when I identified him as "Mr. [REDACTED]". She advised he was very flirty even though his girlfriend was employed at the facility.

I asked her if she noticed anything about the way he reacted towards the girls, and she told me he was too friendly.

I then asked [REDACTED] if she knew about the [REDACTED] situation and she advised that she got fired because of it. She advised there was a girl named [REDACTED] (who she called [REDACTED] who was really touching towards her and write her love notes.

She advised she loved working there but it was "hell". She advised she would tell the leads about [REDACTED] being really touching and would try to put her hand on [REDACTED] lap.

I asked [REDACTED] what she meant when she said [REDACTED] was to touching, and I did let her put her hand on my lap a couple times "lap wise" but she wanted to move up. According to [REDACTED] her stop point was her arms. She advised [REDACTED] was always asking for an exit, and would ask for consistently.

[REDACTED] advised she went to the doctors multiple times because of injuries she received while she was in the facility.

[REDACTED] advised she was supposed to apply to the lead position but they gave it to Mr. [REDACTED] even though [REDACTED] worked there for a longer period.

I then advised [REDACTED] disclosed she had touched [REDACTED]

According to [REDACTED] she knew [REDACTED] told Lauda she fingered my vagina but I am straight I have four kids of my own; she advised she had received notes from [REDACTED] which she gave to TJ, Darion, and J.

I asked what the highest place [REDACTED] had touched and she pointed to her upper thigh, and advised it was approximately 3-4 times. [REDACTED] advised she would cross her legs to prevent it.

[REDACTED] advised she wrote some "Class B's" on [REDACTED] and at one point [REDACTED] gave a Luada a note saying she had fingered [REDACTED]

[REDACTED] advised she had five grievances against her and she was fired because of it.

I asked if she saw the grievances and she advised she had not. I asked if any other juveniles tried to touch her and she denied it.

[REDACTED] provided photos of several notes she received from [REDACTED] and other residences, she allowed me to email it to my work email. I asked her about the "impulses" that [REDACTED] mentioned in her letters to [REDACTED] and she confirmed it was sexual in nature. [REDACTED] advised she gave the letters to management.

[REDACTED] advised [REDACTED] would try to touch her every day and was reporting it now because [REDACTED] was getting all the attention.

[REDACTED] agreed to fill out a written statement, and the following is what she provided:

"[REDACTED] was to touchy got to the point I had to cross my legs and left them towards the table she would ask me to let her touch me or kiss me I kept declining I would tell leads, thy wouldnt take it seriously they only told me to fill out class B's, I would ignore her as much as possible to avoid. She would give me notes I would give them to the leads. I got terminated due to 5 grievances but I asked to see them they denied".

I read her Miranda warnings at approximately 10:20AM, and asked her about the discrepancies between the documents I had been given in on [redacted] and [redacted] from Perimeter Behavioral Health. The following is a summary of the interview, for full interview, see the recorded video footage.

I showed the document showing her termination information and asked why there were no grievances and class b's records.

She advised there were certain groups when she worked at Perimeter and if you were part of the group they would help you stay out of trouble, but she advised she was not part of any the groups at work.

I asked her about the table she sat at and she advised it was a round table and several kids would sit at the table and played cards with them.

[redacted] advised there was an incident where [redacted] had hit her butt when [redacted] was facing away from her. [redacted] advised she did not know what [redacted] had used to hit her butt. [redacted] advised [redacted] would grab her arm.

[redacted] continued to deny allowing [redacted] to touch her.

I asked [redacted] if I could have consent to search her phone and she allowed me to search it after signing the Springdale Police Department Consent to Search. I reviewed several of her messages and did not see anything that would pertain to the case. I asked her what app she was using to text [redacted] and she advised it was textnow.

I spoke with [REDACTED] and asked her about [REDACTED] and she advised she did not want to get [REDACTED] in trouble and when I asked her how high [REDACTED] touched on [REDACTED] leg, she would not answer. I asked [REDACTED] if [REDACTED] had wrote her letters and she denied receiving any.

I asked [REDACTED] what she wanted to happen to [REDACTED] and she advised she didn't want anything to happen.

[REDACTED] advised [REDACTED] had helped her with her urges and she not been on "red sheet" the entire time [REDACTED] had been employed at the facility. [REDACTED] advised [REDACTED] had gotten into trouble for it and they had to move out of camera view but did not elaborate.

[REDACTED] seemed very hesitant to speak about [REDACTED] and advised [REDACTED] didn't tell anyone because she did not want to get [REDACTED] or herself in trouble.
