Description:

With both the suspect and victim being patients at Perimeter Behavior of the Ozarks Dale Chiddister from State Police interviewed [REDACTED] and attempted to interview [REDACTED]. The notes from the interview as placed in the case file. The following is a summary of the interview.

In Chiddister's notes [REDACTED] stated that she had never said anything sexual to [REDACTED] and that [REDACTED] had walked into [REDACTED] room and raped her. [REDACTED] stated that [REDACTED] pulled down [REDACTED] pants and [REDACTED] put her finger in [REDACTED] anus and vagina. [REDACTED] stated that she told [REDACTED] "No" and "Stop". [REDACTED] said that she did not know why [REDACTED] came into her room and did this.

At the end of the interview [REDACTED] said that she did not want to report this and did not want to get [REDACTED] in trouble.

Chiddister told me that he had tried to interview [REDACTED] but [REDACTED] guardian refused to let her be interviewed.

Chiddister also had two attachments which were notes from [REDACTED] and [REDACTED]. One note which was hard to read was reportedly from [REDACTED] to [REDACTED] telling [REDACTED] to rape [REDACTED]. Since the note was hard to read, I called Chiddister and ask for him to confirm what he read in [REDACTED] note to [REDACTED]. Chiddister said that the note was from [REDACTED] asking [REDACTED] to rape [REDACTED] and that she needed to do it without notice or warning.

The other note was from [REDACTED] to [REDACTED]. A summary of the note as follows. [REDACTED] states that she fucked up and did something unforgivable. [REDACTED] said that she knows that [REDACTED] had said that [REDACTED] did not rape [REDACTED] but the fact that [REDACTED] did not stop when [REDACTED] said stop made it rape.

Both notes were placed in the case file.

This case will be closed the listed victim in this case did not want to pursue charges and that statement she made in the interview contradicts the note she wrote to [REDACTED].

According to Chiddister, State Police Hotline was closed unfounded. REN321
