On 10/16/2022 Ptl. S. Cunningham was dispatched to the Perimeter Behavioral Facility in response to one of the juvenile's threatening staff with a knife.

Upon arrival the staff had the juvenile now known as [redacted] held on the ground. Officers quickly took over and began handcuffing the subject. [redacted] resisted for a short time before he was forced into handcuffs. [redacted] was then detained in a patrol car and a report was taken from the victim a Mr. Mark Sackville.

Sackville reported that [redacted] became irate and started breaking the plexiglass window protecting one of the TV's in a break room. When [redacted] broke off a piece of plexiglass that served as a suitable weapon he then began threatening staff yelling to Sackville "get out my way nigga or i'll cut you".

Shortly after staff managed to disarm [redacted] and get him to the ground and hold him until police arrived and took control of the situation.

[redacted] was then relocated to solitary confinement inside of the facility. Due to legal reasons [redacted] could not be transported to a juvenile holding facility to await trial for the incident.

Footage of the incident was captured by the surveillance equipment at the facility but due to management not being present access to the footage could not be collected. Staff was advised of the affidavit process and was notified that an officer will come to the main office soon to collect the footage.
