On 10/25/2022 I Officer Paul Arceneaux was dispatched to the E.R. in reference to an assault report. Upon my arrival I came into contact with (Victim born . I instructed [REDACTED] to explain to me what the situation was. at that point explained that on 10/24/2022 at approx 8:30 P.M. he was attacked by another juvenile ( ) while in his room at Perimeter. stated that during the altercation he was held down by both and while being punched. stated that at one point had his knee on his neck until was able to break free. said that instructed to attack explained that during the scuffle a comb was used to scratch parts of his body by stated that after telling on several occasions to leave his room that Ms. Burks ( A caretaker at Perimeter ) came into his room and informed [REDACTED] to leave but refused. said that Ms. Burks then left and the attacks resumed. then explained, while he was in a headlock applied by , that forcibly penetrated his rectum with the comb.

I Officer Arceneaux had write a voluntary statement of the incident that happen on 10/24/2022 which was signed by his guardian Antuawn Jackson from Perimeter. While talking with Jackson and the staff of Perimeter , Jackson stated that has made several threats to harm and even stated he would " KILL" if he got in trouble over what happen the night prior.
