Employer:

On 11/05/2022, I was dispatched to 161 Skunk Hollow Road (Little Creek Behavioral Hospital) in reference to an employee that was injured by several residents. Dispatch advised there were approximately 14 residents causing a riot in the facility.

When I arrived, other deputies had taken control of the facility and ended the riot. I spoke with Tabitha Cooper who

was the injured employee. I observed a large lump on her forehead that was already bruised. Cooper said she was hit in the back of the head by one of the residents. Once she was hit in the head, she backed up to the wall to get away. She was then punched repeatedly until she fell to the ground. While on the ground she covered her head and was kicked repeatedly. Residents were finally pulled off of her and she was able to get to safety. Cooper also complained of shoulder pain and was holding her arm across the front of her body. I saw no injuries to her shoulder, but she did complain of pain. Cooper said she did not know who caused each specific injury, but she provided names to the three girls who were the main culprits.

Cooper was looked at by Pafford but refused transport. Photographs were taken of her injuries and added to the Patrol Pics Folder. I also collected a statement from Cooper and added it to the case file. She was provided a report number and explained the warrants process.




