**Description:**

On 11/7/22 at approximately 0849 hours I was dispatched to 2466 S. 48th Street (Perimeter of the Ozarks) for an aggressive patient. Upon arrival I made contact with staff members. They stated they had a patient that was being verbally and physically aggressive. The patient identified as [REDACTED] wasn't being cooperative and had to be held down by staff members. At that time [REDACTED] hadn't committed a crime and I left the facility. At 0924 hours I was dispatched back to Perimeter of the Ozarks for the same patient. Upon arrival I made contact with the nurse identified as Reginald Kinney (W/M DOB 12/5/78). He stated that [REDACTED] tried to set off the fire alarm and then forced her way into the medicine room where all the meds are kept. He along with other staff members had to physically remove her from the med room. While they were moving her she bit Mr. Kinney on the back and left a red mark.

While I was speaking with the nurse, Officer Sanders (304) was watching [REDACTED]. She continued to threaten the staff and told them that she would continue to act out until she got to leave. I called the Washington County JDC intake line and spoke with Thomsas Corona. While I was gathering [REDACTED] information, I discovered that she was a ward of the state. JDC decided to take [REDACTED] on our charges. She has a court date of 11/10/22 at 0830 hours. Officer Sanders placed [REDACTED] in handcuffs and transported her to the Springdale Jail. I took pictures of Mr. Kinney's injury and gave him the report number. I also made contact with the director and gave him the report number. I drove to the station and completed the booking sheet and preliminary report. I transported [REDACTED] to the Washington County Juvenile Detention Center. I charged [REDACTED] with battery 2nd felony because Mr. Kinney is a health care worker in a behavioral health facility. JL 308
