On 11/10/2022 I Officer Jerry Williams took a report at the Police Department for Battery 3rd. I spoke to Mr. Dyveon Williams, Mr. Twalyte Hall, and Mr. Xavier Stringfellow who informed me of an incident that happened at Perimeter Behavioral. The stated that while working their normal shift was escorted to the bathroom to take a shower. It was at this time that Mr. attacked another juvenile. After the fight was broke up by staff Mr. attacked the staff then broke away and ran out the door to the outside and attempted to climb the fence. At this time Mr. was restrained and he began hitting the staff again. They were able to restrain Mr. for a short while until he broke free and punched the glass cover on an outside light causing it to break. At this time Mr. grabbed a piece of the glass and held it like a knife. The staff was able to restrain and remove the glass from Mr. and escort him to the quite room. After being placed inside Mr. began hitting the windows and walls repeatedly giving the staff no choice but to restrain him again while he attacked them. Mr. was escorted to the Sunroom where he calmed down and stopped resisting the staff.
