Dispatch stated they could here a male and female yelling in the background but no one was directly on the line. Upon my arrival I walked toward the middle of the building with Officer Barnett #363 and located yelling and pounding on one of the doors to the sleeping quarters. I tried to get her attention but she continued banging on the door and cursing loudly as she did so. I was finally able to get her to turn around but she started walking away. I grabbed her left arm above her elbow and told her not to walk away from me. She yelled and cursed at me telling me not to touch her. I let go thinking she would be calm but she began walking away again. I held onto her arm again and she began pulling away, yelling and screaming as she did so. I faced her toward the wall and chose to detain her in handcuffs due to her demeanor. I was able to successfully get one cuff on her left wrist but she would not comply when I told her to give me her right hand. Officer Barnett had to assist and pull her arm from the front of her body and bring it to the back so I could detain her. Once we did without incident I brought her away from the door so I could speak to her. As I was walking her away she yelled at me multiple times to take the handcuffs off or else she would spit on me and Officer Barnett. Again, she was cursing and yelling profanities so it took a few minutes for me to figure out what she was wanting from us. She told me she called the police and wanted to complain about one of the employees of the center for assaulting her. She was yelling at me the entire time and not answering my questions. When I attempted to get her name from her replied with, "Suck a dick.com." I asked her two more times, but received the same answer both times. I then told her I was there to help her and she slightly deescalated where I could get her name. She eventually told me one of the employees (Jakya Williams B/F dob: 09/10/1998) was insulting her earlier in the day and it made her angry. They began arguing and Ms. Williams then said she was scared for her safety when this happened, thinking she would get hurt. She gave me no details but instead continued yelling and cursing saying we would have to come back because she wanted to go to jail.
