Sarah advised dispatch one of the patients pulled the fire alarm and fled.

While being in route to Perimeter Health Center Sarah informed dispatch the female later identified as [REDACTED] took off in a brown Honda CRV (610 ZWN) (VIN: 2HKRM4H57EH652417) which belongs to an employee later identified as Annalee Chitwood (W/F DOB:5/14/1998). Sarah stated they later noticed [REDACTED] who is also a residence, took off. Sarah was unsure how [REDACTED] left the residence. I asked Sarah if she could provide me with a description for [REDACTED] [REDACTED] was last seen wearing a pink shirt with Black leggings.
