Disturbance

On November 28, 2022 around 1810 hours Deputy Bell responded to 20400 Colonel Glenn in reference to a disturbance. Upon Deputy Bell's arrival contact was made with juvenile [redacted] who stated he got put in restraints by staff members because he touched everyone's food while staff was cooking and he was kicking the cabinets in the kitchen. Deputy Bell asked [redacted] why he did what he did and he stated because they have to rotate between the TV's that have the gaming consoles on them so everyone gets a chance to play the game and he didn't want to abide by the rule. Deputy Bell advised [redacted] he was in the youth home and he has to do as instructed by staff.

Next contact was made with Lamont Ramirez who stated [redacted] stated to them he wasn't rotating today, he not doing shit. Mr. Ramirez stated another deputy had responded to the youth home earlier for [redacted] and another juvenile who had been acting out. Mr. Ramirez stated the other juvenile calmed down some which in return calmed [redacted] down. Mr. Ramirez stated that same juvenile was in the kitchen helping Mr. Bill cook and [redacted] could handle the fact the other juvenile had calm down. Mr. Ramirez stated [redacted] was in the kitchen pulling his feet up near where the food was and picking in his nose and acting as if he was going to touch other people's food.

Mr. Ramirez stated he asked [redacted] not to do that, he then turned around and started kicking the bottom shelves in the kitchen. Mr. Ramirez stated he asked [redacted] not to destroy any more property being you have already destroyed everything in here. Mr. Ramirez stated [redacted] replied I don't care and began to kick even harder. Mr. Ramirez stated they asked [redacted] to leave out of the kitchen. Mr. Ramirez stated when they were putting [redacted] in restraints, he accidentally head butted him. Mr. Ramirez stated this is an everyday occurrence with [redacted] and he refuses to follow instruction from staff. Lastly contact was made with Mr. Bill who stated [redacted] was threatening to do something to them and just acting a fool and they did the legal hold.
