On 12/12/2022 I Officer Walters received a call from dispatch about an assault on a employee at 211 Church (Dacus RTC). When I arrived Mr. Charles Sigman(DOB: 1/24/1966) met me at the door. Mr. Sigman presented with a busted lip that did appear to still be bleeding. I offered ems and Mr. Sigman refused them at this point. Mr. Sigman took me back to the juvenile and the juvenile told me that they was trying to give him a shot in his bottom and was not showing any signs of aggression in my presence. The juvenile also did not admit to anything in my presence, he just kept asking how many days is he going to be in jail. Mr. Sigman was asked at this point if he wanted to file charges and Mr. Sigman did want to file them as his lip is busted and still actively bleeding. Mr. Sigman thought he might need stitches and did agree to have ems go ahead and come check him out. Mr. Sigman said he also got punched on both sides of the head by the juvenile and did refuse transport when ems arrived. I contacted Officer Anderson with the Juvenile Probation Office who advised me originally to cite and release the juvenile but when I told the facility staff they advised me that he has hit another child in the facility earlier today along with destroying some of the facility property. I contacted Officer Anderson again and told her the facilities concerns about the juvenile and she then advised me to go ahead and transport the juvenile to the detention center. I took the juvenile into custody and transported him to the Craighead County Juvenile Detention Center with no further incident.

Mr. Sigman gave a victim statement that is attached in the file with this report along with Mr. Perkins witness statement.
