On 12/20/2022 I was dispatched to 211 Church to the Methodist Family Health Center on a report of an assault of two staff members. I was told that [REDACTED] had assaulted two staff members and had taken the keys to the facility from one of the staff members and left the facility on foot. After a through search of the area I was unable to locate the three juveniles.

An attempt was made to enter these juveniles as missing but Methodist Family Health could not furnish me with a fiscal description of the subjects i was told that it would be in the morning of 12/21/2022 before i was able to receive a physical description of the subjects.
