Narrative & Statements

Narrative - Parrish, Michael - 12/22/2022 3:49:04 PM (Initial)

On December 22, 2022 I was dispatched to Dacus in regards to 4 Juvenile males kicking the door open and leaving the facility. I arrived and made contact with Cody Perkins. He advised the male juveniles was in the day room and kicked the door till it came open and then ran out the front door.

Craighead 33 located on Juvenile male and turned him back over to dacus. The other three males ran when Deputy tried to make contact. we searched the area and couldnt locate the other three males. The three male subjects have been entered at runaway Juv.

Narrative - Walters, Kole - 12/22/2022 6:06:09 PM (Initial)

On 12/22/2022 I Officer Walters was notified by dispatch that two of the juvenile had returned to Dacus RTC. When I arrived at Dacus I was advised that juvenile 3 and juvenile 4 have both returned to the facility. I contacted the Craighead County Sherriffs Office to have them removed as runaways. Facility staff did advise me that the other two juveniles may be headed to juvenile 2's mothers house in Jonesboro. I was given an address of 3111 Fairview Dr. I passed this info along to Jonesboro Police Department for a unit to check the address. At approximately 7:30PM I made contact with a Ms. Henderson the mother of juvenile 2 who told me that he is on probation with Flora Anderson and that he has showed up at his grandmothers house. Ms. Henderson gave me an address of 410 N 3rd in Jonesboro and Jonesboro Police Department did make contact with juvenile 2 at this address. I advised Dacus that the juvenile 2 had been found and I was told by Cody Perkins that he had been discharged from them following this incident and several other incidents by Dr Vanscoy. I made contact with Flora Anderson with juvenile and informed her of the incident and she advised to return him to his mothers and she would pick the report up. I advised 163 with Jonesboro of the PO decision and he said he would take him to his mothers. Juvenile 1 was found a short time later at the 410 N 3rd address and was returned to Dacus via Jonesboro Police department and all juveniles have been removed as runaways by Jonesboro 911.
