Narrative

On December 31, 2022 at approximately 1901 hours I was dispatched to the area of East German and highway 286 to attempt to locate two juveniles (offenders) who had run away from Little Creek Behavioral Health (Victim business).

As I was traveling East on highway 286 near Rowlett In, I observed two males matching the description walking West on the North side of Highway 286. I stopped and asked the individuals for their names and they identified themselves as the two runaways. Ms. Angela Barker (Complainant) arrived on scene and confirmed they were the juveniles that ran away. I transported the two juveniles back to Little Creek Facility, and released them to facility staff.

I made contact with Mr. Quindariean Coleman (OI) in the lobby of the facility. Mr. Coleman stated that the juveniles were out front with him, and when he told them it was time to go inside the juveniles took off running around the pond and into the woods. Mr. Coleman stated he called the Sheriff's office to report the run away and was advised to call back after about an hour to see if the juveniles would return.

The juveniles were released to Mr. Coleman and facility personnel.
