Primary Narrative By Dylan Burke, 01/11/23 15:10

Battery

On 1/11/2023 (Wednesday), at approximately 1510 hours, I was dispatched to 20400 Colonel Glenn Road (Youth Home) in reference to a physical disturbance. Dispatch advised that staff is trying to separate 3 students and needs a Deputy to respond. I responded light and sirens to the scene.

On arrival, I observed several staff members, who had [redacted] restrained on the ground with their combined body weight. I placed [redacted] in hand restraints. I double locked them to prevent tightness and I assisted him off the ground. I placed him in the back of my patrol unit. Sgt. Kirkwood detained [redacted] in the Sturgis House of the Youth Home.

I made contact with the Administer (Peggy Kelly), who provided me with face sheets of all the juveniles involved ([redacted] and [redacted]). Sgt. Kirkwood and I made contact with witnesses, Stephen Webb and Jonathan Pulliam. Jonathan advised that [redacted] and [redacted] were involved in a physical altercation with [redacted] being the primary aggressor of the altercation. Jonathan advised that [redacted] was threatening his roommate ([redacted]). Jonathan advised that [redacted] attempted to attack [redacted] but staff restrained him. Jonathan advised while in the midst of attempting to restrain [redacted] that he elbowed Caitlin Henthorne several times in the arm and kicked Emma Nix several times. Deputies made contact with Stephen Webb, whom advised that while restraining [redacted], he observed him kick Emma in the side.

I made contact with both victims. Caitlin advised that [redacted] attempted to assault another juvenile. Caitlin advised while staff was attempting to restrain [redacted] that he struck her in the left arm several times and Emma Nix was kicked. I observed redness on Caitlin's left upper arm.

I made contact with Emma Nix, who advised that she was attempting to restrain [redacted] after he attempted to assault another juvenile. Emily advised that in the midst that she was restraining [redacted] that he kicked her in the abdomen.

I took pictures of Caitlin's injuries and uploaded them to evidence.

Emma and Caitlin advised that they did not need medical attention.

I made contact with _____ at my patrol unit, who advised that he did not medical attention.

I contacted the Pulaski County Juvenile Intake Officer, Elizabeth Mahan, and advised her of the situation. Officer Mahan advised to issue _____ a court date of 3/14/2023 at 0930 hours at the Pulaski County Juvenile Court.

Arrest Deposition Report was completed. Peggy signed as the guardian for

Emma, Caitlin, Stephen, and Jonathan all completed witness statements, which were submitted into evidence.

I made contact with _____ and removed his hand restraints. I advised him of his court date and he signed the Arrest Deposition Report.
