## Narrative &amp; Statements

Narrative - Kennedy, Jordon Lee - 1/14/2023 1:34:11 PM (Initial)

On Friday January 13, 2023 I was dispatched to 211 Church Street in reference to an assault that had already occurred. When I arrived on scene I made contact with Charles Sigman. Sigman advised me that a male juvenile had punched him several times in the top of the head as he attempted to keep the subject from attacking another juvenile. I contacted Amy Powell and she advised that the jail was currently full and the facility needed to contact DCFS in reference to the juvenile client. I advised the staff of this and the became upset stating that the suspect had a continuing behavior of assaulting staff and other clients. I advised them that there was nothing that I could do and once again to contact the case worker in charge of the suspect. I spoke with the suspect and he seemed to be calm. He stated that he was going to keep acting out until he was transferred to another facility. I advised him that the staff was trying to have him removed and to give them a few days to do so. He agreed to behave as long as he didn't have to stay there anymore.
