On 1/17/23 a report was received from Arkansas State Police Investigator Ying Merritt in regards to a new report.

The DHS snapshot was reviewed and the following is a summary of the report.

AV is [REDACTED] [REDACTED] is currently in the custody of Texas DHS and is currently a resident at Perimeter Behavioral Health of the Ozarks in Springdale, AR. The AO is a fellow resident, [REDACTED] [REDACTED] has indicated that during a hug, [REDACTED] grabbed her butt. It is believed that [REDACTED] did this for sexual purposes. The contact was not wanted by [REDACTED]. A date for the incident is unknown. It is unknown how [REDACTED] reacted to the incident. Until recently, [REDACTED] and [REDACTED] lived in the same unit at Perimeter, however, after being made aware of the incident, the two have been moved to separate units. In a separate incident, [REDACTED] licked and sucked on another resident's, [REDACTED] neck. This incident occurred on 1/14/2023. [REDACTED] is believed to have done this for sexual purposes. I received the hotline at 0900 hours on January 17th. I made contact with Investigator Ying with State Police and we agreed to meet at the Perimeter Behavioral Unit at 1300 hours to meet with the victim.

Forensic Interviewer Ying conducted the interview in the conference room at the Perimeter Center. The victim, [REDACTED] stated that a girl named [REDACTED] touched her butt. [REDACTED] real name is [REDACTED] and is a female that identifies as a male so for the rest of the report she will be identified as a male named [REDACTED]. [REDACTED] stated that it happened on Saturday because [REDACTED] did something to somebody else too. [REDACTED] stated that [REDACTED] gave [REDACTED] a hickey and it made her mad. [REDACTED] stated that she was going to beat up [REDACTED].

Ying asked if [REDACTED] touched her under or over her clothes and she stated "over". Ying asked her what [REDACTED] said and [REDACTED] stated, "he rubbed my butt over my shorts as he walked by me and just said "goodnight". Ying asked if [REDACTED] did anything else and she stated "no". Ying asked [REDACTED] if she said anything back to [REDACTED] and she stated "no, I was too freaked out to say anything." I asked [REDACTED] if she was in a relationship with [REDACTED] and she stated "yes I am". The interview was ended, and she was sent back to her room.

Ying also interviewed [REDACTED] and she talked about [REDACTED] coming up to give her a hug and she sucked and bit her neck. [REDACTED] stated that she pulled away from [REDACTED] and left the room. Ying recorded both interviews and this is a summary of those interviews.

There was not enough disclosed to press charges against [REDACTED] based off their statements.
