Mr. Perkins told me that after [REDACTED] got aggressive with other staff members he decided to approach him to see if he cool the situation down and that's when [REDACTED] started swinging at Mr. perkins . Mr. Perkins said that he grabbed [REDACTED] and took him to the floor [REDACTED] was very upset about this and he bit Mr. Perkins on his left arm.
