NARRATIVE

OFFICERS RESPONDED TO THIS LOCATION (METHODIST CHILDREN'S HOME) IN REFERENCE TO A RUNAWAY JUVENILE. OFFICERS SPOKE WITH EMPLOYEE SHAY WHITAKER UPON ARRIVAL. MS. WHITAKER ADVISED AROUND 1930 HOURS, JUVENILE 1 WALKED OUT OF THE FRONT DOOR OF THE FACILITY AND JUMPED THE FENCE, WALKING NORTHBOUND. MS. WHITAKER ADVISED JUVENILE 1 IS A FREQUENT RUNAWAY AND USUALLY STAYS GONE FOR A FEW HOURS. MS. WHITAKER DESCRIBED JUVENILE 1 AS A SKINNY W/M WITH DIRTY BLONDE HAIR, 5'5 AND 140 LBS. MS. WHITAKER ADVISED JUV. 1 WAS LAST WEARING A BLACK SHIRT WITH GREY HOODIE, BLACK JEANS, AND BLACK AND WHITE SNEAKERS WITH YELLOW ON THEM. MS. WHITAKER ADVISED JUV. 1 HAS BEEN LOCATED BEFORE NEAR THE AREA OF "POP-A-TOP" LIQUOR. JUV. 1 SUFFERS FROM ADHD BUT HAS NO OTHER KNOWN MEDICAL CONDITIONS NOR TENDENCIES THAT WOULD MAKE HIM VIOLENT TOWARDS HIMSELF OR OTHERS. OFFICERS CIRCULATED FOR JUV. 1 WITH NEGATIVE RESULTS AND ISSUED MS. WHITAKER AN INCIDENT CARD ON SCENE. NCIC MISSING PERSONS REPORT FILLED OUT ON SCENE. MVR AND BWC IN USE.
