**NARRATIVE**

OFFICERS RESPONDED TO METHODIST CHILDREN'S HOME LOCATED AT 2002 SOUTH FILLMORE STREET IN RELATION TO A RUNAWAY JUVENILE CALL, REPORTED BY MS. SANDERS. COMMUNICATIONS ADVISED MS. SANDERS STATED ONE OF THE CHILDREN, JUVENILE 1, RAN AWAY FROM THE LOCATION AT APPROXIMATELY 0750 HOURS.

UPON ARRIVAL, OFFICERS MADE CONTACT WITH MS. SANDERS. SHE ADVISED THE SAME INFORMATION. SHE ADVISED THE JUVENILE LEFT TO AN UNKNOWN LOCATION. SHE STATED OTHER CHILDREN OVERHEARD JUVENILE 1 STATE HE WAS GOING TO WALK TO HIS SCHOOL, WHICH WAS THE METHODIST DAY TREATMENT SCHOOL. THE SCHOOL WAS NOTIFIED TO MAKE PROPER NOTIFICATIONS IF JUVENILE 1 ARRIVED TO THE SCHOOL. AT THE TIME OF NOTIFICATION, THE SCHOOL ADVISED JUVENILE 1 WAS NOT AT THE SCHOOL. MS. SANDERS ADVISED JUVENILE 1 WAS LAST SEEN WEARING A NEON GREEN HOODIE, KHAKI PANTS, AND WHITE NIKE SHOES WITH A RED NIKE LOGO. OFFICERS COMPLETED A NCIC PERSON SUPPLEMENT FORM AND MS. SANDERS SIGNED IT; IT WAS LATER ATTACHED TO THIS REPORT VIA RMS. OFFICERS CIRCULATED THE AREA IN AN ATTEMPT TO LOCATE JUVENILE 1, WITH NEGATIVE RESULTS.

OFFICERS EMAILED ACIC ENTRIES AND DELETIONS SO THE JUVENILE COULD BE ENTERED INTO THE SYSTEM AS A RUNAWAY.
